1. Work Choice Wage Incentive

You may have seen Andrew Thomas' letter to Work Programme providers, dated 18th July, which declares that the last employment start date for which a Wage Incentive can be claimed is 6th August 2014. Work Choice providers should be clear that this deadline does not currently apply to the Work Choice Wage Incentive. The last employment start date for Work Choice Wage Incentive claims is still under consideration.
