1. You approached the Committee about taking up an appointment as a Chairman for the Sarikhani Foundation.

The Committee's role and remit

2. It is the Committee's role to advise on the conditions that should apply to appointments or employment under the Government's Business Appointments Rules for Former Ministers (the Rules), which apply to former Ministers for two years after they leave office. The Rules seek to counter suspicion that:
  - a) the decisions and statements of a serving Minister might be influenced by the hope or expectation of future employment with a particular firm or organisation; or
  - b) an employer could make improper use of official information to which a former Minister has had access; or
  - c) there may be cause for concern about the appointment in some other particular respect.
3. When the Committee considers applications, it must have in mind that Government has judged that it is in the public interest that former Ministers with experience in Government should be able to move into business or into other areas of public life, and to be able to start a new career or resume a former one. It is equally important that when a former Minister takes up a particular appointment or employment, there should be no cause for any suspicion of impropriety.
4. It is not the Committee's role to pass judgment on whether an appointment is appropriate or suitable in any other regard.

Appointment Details

5. You seek to take up an appointment with the Sarikhani Foundation. You told the Committee this organisation was recently established by Ina Sandman and Ali Sarikhani as a means of promoting their collection of art to a wider audience.
6. You confirmed you had no official dealings with the Sarikhani Foundation during your last two years in office. Further, you are not aware of any relationship between the Sarikhani Foundation and the Home Office; and had no dealings with its competitors, nor access to commercially sensitive information about competitors.
7. The Permanent Secretary at the Home Office was consulted and confirmed to the Committee: the Home Office has no relationship with the Sarikhani Foundation and it has no concerns about you taking up this appointment.

The Committee's consideration

8. When considering this application, the Committee<sup>1</sup> took into account this appointment has no connection with your ministerial role as Parliamentary Under Secretary for Immigration. It particularly noted you had no dealings with the Sarikhani Foundation whilst in office and your former department confirmed it has no relationship with the Sarikhani Foundation. Therefore, the Committee considered the risk it might be perceived this appointment is a reward for decisions made or actions taken from your time in office is low.
9. As there is no connection to your time in office, the Committee also considered the risks associated with your access to sensitive information are also low. The Committee did not consider this appointment raises any particular propriety concerns under the Government's Business Appointment Rules. However it would like to draw your attention to the conditions below. In particular, the restriction that prevents you from using contacts gained in office to the unfair advantage of your new employer.
10. Taking into account these factors, in accordance with the Government's Business Appointment Rules, the Committee advises this appointment be subject to the following conditions:
  - You should not draw on (disclose or use for the benefit of yourself or the persons or organisations to which this advice refers) any privileged information available to you as a Minister; and
  - for two years from your last day in Ministerial office, you should not become personally involved in lobbying the UK Government on behalf of the Sarikhani Foundation (including parent companies, subsidiaries and partners). Nor should you

make use, directly or indirectly, of your government and/or Ministerial contacts to influence policy, secure funding/business or otherwise unfairly benefit the Sarikhani Foundation (including parent companies, subsidiaries, partners and clients).

11. By 'privileged information' we mean official information to which a Minister or Crown servant has had access as a consequence of his or her office or employment and which has not been made publicly available. Applicants are also reminded that they may be subject to other duties of confidentiality, whether under the Official Secrets Act, the Civil Service Code or otherwise.
12. The Business Appointment Rules explain that the restriction on lobbying means that the former Crown servant/Minister "*should not engage in communication with Government (Ministers, civil servants, including special advisers, and other relevant officials/public office holders) – wherever it takes place - with a view to influencing a Government decision, policy or contract award/grant in relation to their own interests or the interests of the organisation by which they are employed, or to whom they are contracted or with which they hold office.*"
13. I should be grateful if you would inform us as soon as you take up this role, or if it is announced that you will do so, either by returning the enclosed form or by emailing the office at the above address. We shall otherwise not be able to deal with any enquiries since we do not release information about appointments that have not been taken up or announced. This could lead to a false assumption being made about whether you had complied with the Rules and the Ministerial Code.
14. Please also inform us if you propose to extend or otherwise change the nature of your role as, depending on the circumstances, it may be necessary for you to make a fresh application.
15. Once the appointment has been publicly announced or taken up, we will publish this letter on the Committee's website, and where appropriate, refer to it in the relevant annual report.
