Thank you for your email of 17th April 2020 requesting the following information:

"By "key programmes", I mean those that are listed in the Defence Equipment Programmes for the given year. I have asked for the spend data for 2016-17 previously - which I believe is the spend data that covers the programmes listed in the Defence Equipment Plan 2017 p45 - but was told that this data was not available.

A question that will - hopefully - simplify things: does the table on p45 refer to the programmes that saw spending in FY2016-17? If so, I'd like this data, as has been provided for every year before and since FY16-17. If the data in the table refers to a different FY, can I receive the data, on the same basis, that refers to the in-year spending for FY2016-17?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that all the information in scope of your request is held.

The information you have requested can be found at annex A.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact us in the first instance at the address above. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MOD internal review process has been completed.
