FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: NON-CRIME HATE INCIDENTS.

We refer to your email dated 5 December 2019 to the Ministry of Defence Police which was acknowledged on the same date.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

"For each of the financial years 2015, 2016, 2017, 2018 and 2019 (to date) can you please provide the following information:

1. The number of non-crime hate incidents (also known as hate incidents), as defined by the College of Policing, recorded by the Force.

2. The category recorded for each incident eg transphobia, racism, misogyny.

3. For each incident, whether any police visits were made. Please say in each case whether the visits were to the complainant, the subject of the complaint, or any witnesses."

A search for information has now been completed by the Ministry of Defence Police (MDP) and I can confirm that we do hold information in scope of your request.
