Origins of UK food law




- In the Middle Ages, UK traders formed Guilds to regulate trade in precious metals, spices, drugs and other high-value items
- Prior to the first general food act, Special Statutes dealt with bread, tea, coffee, beer and wine to prevent defrauding of revenue and to protect purchaser health
- By the 19th century, concern wrt the quality, contamination and adulteration of food
- The Adulteration Act, 1860 (amended 1872) included appointment of Public Analysts
- The Sale of Food and Drugs Act in 1875, amended 1879 and 1899



UK food law and the Government Chemist





- The Merchandise Marks Acts, 1887, 1891 & 1894
 dealt with mis-labelling of imported foods
- The Fertilizer and Feeding Stuffs Act, 1906 included appointment of agricultural analysts
- The Public Health Act, 1907 included regulations as to foods
- Parliamentary Select Committee, 1874
 proposed a central referee 'Chemical Officers of Somerset House'



- Responding to enquiries (>75 in 2019)


