Dear Thank you for your email of 8 August 2019 to the Ministry of Defence (MOD) clarifying the format of the answers you require to your email of 30 July 2019 which requested the following information:

- 4. Have any additional measures been taken by the department, in 2019, to help civil servants deal with stress?
- 5. How much overtime did civil servants in the department work this year from Jan 1st up to 31 May 2019?
- 6. What is the equivalent number of overtime worked in the same time period (Jan 1st May 31) in a) 2018; b) 2017; c) 2016; d) 2015; e) 2014?
- 7. How much overtime did civil servants in the department work in total in a) 2014; b) 2015; c) 2016; d) 2017; e) 2018? "

You have clarified the following:

"Qs 5-7 in terms of cost. if this isn't possible, the number of hours would be fine"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that all information in scope of your request is held subject to the caveats noted. The answers to your questions are as follows:

Q1. How many sick days have civil servants in this department taken this year from Jan 1st up to 31st May 2019?

Q4. Have any additional measures been taken by the department, in 2019, to help civil servants deal with stress?

The Ministry of Defence is committed to supporting the physical and mental health and wellbeing of all its staff. A range of guidance materials is available to managers and employees to support all staff in managing stress in the workplace and specific support is also available via the Department's Employee Services, which includes a Civilian Staff Counselling Service that aims to reduce sick absence attributable to work related stress. The Department also has in place circa 1,500 Mental Health First Aiders across the Defence Estate and is currently revising a stress assessment tool to ensure it aligns more closely with HSE standards.

The department has benchmarked itself against the core and enhanced standards in the 'Thriving at Work Report'. To ensure the Department meets the standards we have recently introduced a new Supporting Attendance policy and a new 'Line Managers in Defence' training course, both of which have a strong emphasis on wellbeing and encourage high quality and honest conversations between managers and staff to enable timely and appropriate support to be provided. To date, around 80% of our Senior Civil Servants attended Wellbeing Confident Leaders workshops and we have developed a new Senior Leaders Course on Resilience and Wellbeing, which are designed to ensure a culture that prioritises health and wellbeing.

- Sick absence figures have been taken from Human Resources Management System (HRMS) and only include individuals with a Personnel Status of 'Employee'.
- All figures presented are for MOD Main only and exclude agencies, trading funds and arm's length bodies, but include Defence Equipment & Support.
