Non-technical summary

This noise and vibration monitoring report fulfils HS2 Limited's commitment detailed in the Environmental Minimum Requirements (EMRs), Annex 1, Code of Construction Practice, to present the results of noise and vibration monitoring carried out within the Solihull Metropolitan District (SMD) during the month of June 2020.

This report presents data from two noise monitoring installations near the Park Lane worksite and two noise monitoring installations near the Work Package 62 (WP62) worksite. Works at the Park Lane worksite included construction of an earth bund. Works at the WP62 worksite included earthworks and construction works on the new attenuation pond east of the B4438 roundabout, excavation of utility trench, installation of post and rail timber fencing, service crossing and utility works.

The measured noise levels in June exceeded guideline criteria for significant adverse effects on one occasion. This was due to utility installation daytime works at the entrance to the Holiday Inn Express hotel, however due to the large separation distance noise levels at the hotel are calculated to be below the criteria.

No exceedances of Section 61 trigger levels were measured due to HS2 related works during the monitoring period.

One noise complaint was received from HS2 during the monitoring period. Details of the complaint and results of investigation are presented in Table 6 of this report.

Ambient sound	A description of the all-encompassing sound at a given location and time which will include sound from many sources near and far. Ambient sound can be quantified in terms of the equivalent continuous sound pressure level, L _{pAeq,T}
Decibel(s), or dB	Between the quietest audible sound and the loudest tolerable sound there is a million to one ratio in sound pressure (measured in Pascal (Pa)). Because of this wide range, a level scale called the decibel (dB) scale, based on a logarithmic ratio, is used in sound measurement. Audibility of sound covers a range of approximately 0-140dB.
Decibel(s) A- weighted, or dB(A)	The human ear system does not respond uniformly to sound across the detectable frequency range and consequently instrumentation used to measure sound is weighted to represent the performance of the ear. This is known as the 'A weighting' and is written as 'dB(A)'.
Equivalent continuous sound pressure level, or L _{pAeq,T}	An index used internationally for the assessment of environmental sound impacts. It is defined as the notional unchanging level that would, over a given period of time (T), deliver the same sound energy as the actual time-varying sound over the same period. Hence fluctuating sound levels can be described in terms of an equivalent single figure value, typically expressed as a decibel level.
Façade	A facade noise level is the noise level 1m in front of a large reflecting surface. The effect of reflection, is to produce a slightly higher (typically +2.5 to +3 dB) sound level than it would be if the reflecting surface was not there.
Free-field	A free-field noise level is the noise level measured at a location where no reflective surfaces, other than the ground, lies within 3.5 metres of the microphone position.
Exclusion of data	Measurement of noise levels can be affected by weather conditions such as prolonged periods of rain, winds speeds higher than 5m/s and snow/ice ground cover. Noise levels measured during these periods are considered not representative of normal noise conditions at the site and, for the purposes of this report, are excluded from the assessment of exceedances and calculation of typical noise levels and are also greyed out in charts. Identifiable incongruous noise and vibration events not attributable to HS2 construction noise are also excluded.
Peak particle velocity, or PPV	Instantaneous maximum velocity reached by a vibrating element as it oscillates about its rest position. The PPV is a simple indicator of perceptibility and risk of damage to structures due to vibration. It is usually measured in mm/s.
Sound pressure level	The parameter by which sound levels are measured in air. It is measured in decibels. The threshold of hearing has been set at 0dB, while the threshold of pain is approximately 120dB. Normal speech is approximately 60dB at a distance of 1 metre and a change of 3dB in a time varying sound signal is commonly regarded as being just detectable. A change of 10dB is subjectively twice, or half, as loud.
Vibration dose value, or VDV	An index used to evaluate human exposure to vibration in buildings. While the PPV provides information regarding the magnitude of single vibration events, the VDV provides a measure of the total vibration experienced over a specified period of time (typically 16h daytime and 8h night-time). It takes into account the magnitude, the number and the duration of vibration events and can be used to quantify exposure to continuous, impulsive, occasional and intermittent vibration. The vibration dose value is measured in m/s ^{1.75} .

1 Introduction

- 1.1.1 The nominated undertaker is required to undertake noise (and vibration) monitoring as necessary to comply with the requirements of the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, including specifically Annex 1: Code of Construction Practice, in addition to any monitoring requirements arising from conditions imposed through consents under Section 61 of the Control of Pollution Act, 1974 or through Undertakings & Assurances given to third parties. Such monitoring may be undertaken for the following purposes:
 - monitoring the impact of construction works;
 - to investigate complaints, incidents and exceedance of trigger levels; or
 - monitoring the effectiveness of noise and vibration control measures.

Monitoring data and interpretive reports are to be provided to each relevant local authority on a monthly basis and shall include a summary of the construction activities occurring, the data recorded over the monitoring period, any complaints received, any periods in exceedance of agreed trigger levels, the results of any investigations and any actions taken or mitigation measures implemented. This report provides noise data, and interpretation thereof, for monitoring carried out by HS2 within the Solihull Metropolitan District (SMD) area for the period 1st to 30th June 2020.

- 1.1.2 Active construction sites where noise monitoring was undertaken in the local authority area during this period include:
 - Park Lane worksite (see plan 1 and 2 in Appendix A), where site activities included construction of an earth bund. All site activities in June were undertaken during core working hours between 08:00-18:00 on weekdays.
 - Work Package 62 (WP62) worksite (see plan 1 and 3 in Appendix A), where site activities included earthworks and construction works on the new attenuation pond to the immediate east of the B4438 roundabout, excavation of utility trench parallel to the B4438 and around the Fujitsu factory, installation of post and rail timber fencing to the west of the B4438, utility installation works at the entrance to the Holiday Inn Express hotel and utility works on the eastern side of Northway. Site activities in June were undertaken during core working hours (between 08:00-18:00 on weekdays and 08:00-13:00 on Saturdays).

Further utility works were also undertaken in Kenilworth Road, Balsall Common (gas line between Austey and Barston); and along East Car Park Road, NEC Birmingham (works at overhead power lines).

1.1.3 The applicable standards, guidance, and monitoring methodology is outlined in the construction noise and vibration monitoring methodology report which can be found at the following location https://www.gov.uk/government/collections/monitoring-the-environmental-effects-of-hs2. 1.2 Measurement Locations

2 Summary of results

2.1 Exceedances of LOAEL and SOAEL

- 2.1.1 The lowest observed adverse effect level (LOAEL) is defined in the Planning Practice Guidance Noise as the level above which "noise starts to cause small changes in behaviour and/or attitude, e.g. turning up volume of television; speaking more loudly; where there is no alternative ventilation, having to close windows for some of the time because of the noise. Potential for some reported sleep disturbance. Affects the acoustic character of the area such that there is a perceived change in the quality of life".
- 2.1.2 The significant observed adverse effect level (SOAEL) is defined in the 'Planning Practice Guidance Noise' as the level above which "noise causes a material change in behaviour and/or attitude, e.g. avoiding certain activities during periods of intrusion; where there is no alternative ventilation, having to keep windows closed most of the time because of the noise. Potential for sleep disturbance resulting in difficulty in getting to sleep, premature awakening and difficulty in getting back to sleep. Quality of life diminished due to change in acoustic character of the area."

- 2.1.3 Where construction noise levels exceed the SOAEL, relevant periods will be identified and summary statistics provided in order to evaluate ongoing qualification for noise insulation and temporary rehousing.
- 2.1.4 Table 3 presents a summary of recorded exceedances of the SOAEL due to HS2 related construction noise at each measurement location over the reporting period, including the number of exceedances during each time period.

⁽¹⁾ SOAEL exceedance caused by service crossing works at the entrance of the Holiday Inn Express Hotel and in close proximity to the noise monitor. In consideration of the large separation distance noise levels at the hotel (approximately 70m away) are calculated to be below the SOAEL.

- 2.1.5 HS2 construction activities were undertaken between 08:00 and 18:00 on weekdays at the Park Lane worksite, and between 08:00 and 18:00 on weekdays and between 08:00 and 13:00 on Saturdays at the WP62 worksite.
- 2.1.6 Noise levels above the SOAEL were measured at monitoring location Loc 4 due to service crossing works being undertaken in proximity to the monitor. However, due to the large separation distance, noise levels at the nearest receptor locations are calculated to be below the SOAEL.

2.2 Summary of measured noise levels

2.2.1 Table 4 presents a summary of the measured noise levels at each monitoring location over the reporting period. The $L_{Aeq,T}$ is presented for each of the relevant time periods averaged over the calendar month, along with the highest single period $L_{Aeq,T}$ that was found to occur within the month.






Worksite: Park Lane – Monitoring Ref: Loc 1
















Worksite: Park Lane – Monitoring Ref: Loc 2















Worksite: WP62 – Monitoring Ref: Loc 3














Worksite: WP62 - Monitoring Ref: Loc 4
