"To receive the in-year spend totals for each of the programmes listed on page 51 of the Defence Equipment Plan 2019. This would refer to spending for the Financial Year 2019-20. This data has been provided me previously, for over 6-years, most recently 15 June 2020 (FOI2020/04646). As such:

1. The data is held centrally.

2. It is not deemed to be commercially sensitive.

3. It is not deemed to be an operational security matter."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that all the information in scope of your request is held.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MOD internal review process has been completed.
