"Please could I have the statistics on 1.Rape and 2.Domestic Violence that is given under the heading 'Violence and Sexual Assault.'
Please could I have:

- 1. Total number of reported rapes by year, detailed separately per year for 2015, 2016, 2017, 2018, 2019 and outcome result.
- 2. Total number of reported domestic violence cases from 2015, 2016, 2017, 2018, 2019 and outcome result.
- 3. A further breakdown of the reason for the outcome 99. Removed Crime (No Crime)."

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

Question 1:

Total number of reported rapes by year, detailed separately per year for 2015, 2016, 2017, 2018, 2019 and outcome result.

Any allegations of rape are handed over to the local Home Office Police Force in accordance with Home Office Circular 28/2008.

Question 2:

Total number of reported domestic violence cases from 2015, 2016, 2017, 2018, 2019 and outcome result.
