Thank you for your application received on 17 October 2018.

I need to ask you for some missing information before I can do any more work on your application. Please provide us with more information with respect to the following points:

### 1. Application form Part C2

- Q3b asks for confirmation of registration with a certified technical competence scheme. You have provided an
  original operator competence certificate for Lee Jepson that is dated 27/11/2015. As the certificate is over 2 years
  old, you must provide a continuing competency certificate for Lee Jepson. You must also complete the table in
  question 3b which asks about the other sites Lee is also a technically competent manager for. If the answer is none,
  you must state that in the table.
- Q3d asks about management systems. You have ticked the box to state that the facility meets ISO14001 certification. Please provide evidence of the certification. If you have your own management system that is not certified, you need to state this in a revised Part C2 application form.
- Q5e asks that you provide a baseline report if you are adding an installation. As you are adding an installation
  activity to your permit you are required to provide a baseline report which includes spoil and groundwater data.
  However, if you choose not to provide a site baseline report, provide confirmation that you are accepting a "zero
  contamination status" for your site.

Please send the information and payment within 10 working days of this letter. Details of how to pay are given in Part F of the application form. If we do not hear from you, we must return your application.

When we receive the requested information and payment, we will continue to check your application. We will check to see if there's enough information for the application to be 'duly made'. Duly made means that we have all the information we need to begin determination. Determination is where we assess your application and decide if we can allow what you have asked for.

We will let you know by letter whether your application can be duly made. If it cannot be duly made, we will return your application to you.

If we do have to return your application we will send you a partial refund of your application payment. We will retain 20% of the application charge to cover our costs in reviewing your application and requesting information. This maximum amount we'll retain is capped at £1,500. ### Other points

Please be advised that we have noted the following points in the documents you have provided. You will be required to

address these points during the determination stage.

• The WYG air quality impact assessment dated May 2018 does not include all designated habitats within the relevant screening distance for an installation activity (10 km for SACs, SPA's and Ramsars and 2 km for SSSIs, Local Nature Reserves, Local Wildlife Sites and Ancient Woodlands). There are two Designated Sites within 10 km of the facility and these have not been included in the assessment. An updated air quality impact assessment will be required together with the model input files.
