Unannounced inspection to determine permit compliance and review progress since Audit conducted in June 2019.

Compliance Director Lee Jepson met upon arrival and prior to leaving site. Shown around operational area by site manager.

Weather: No precipitation at time of inspection with light breeze (rain earlier). Temperature around 8oc.

We were met immediately on arrival by Mr. Jepson who informed us that the company was being subjected to an audit by a 3rd party body. We were told that such was the extent of the audit that nobody was available to show us around the site. Having insisted on at least viewing the site and undertaking our own dynamic risk assessment, we were provided with a member of staff to escort us around the facility. Almost an hour had elapsed before we were able to enter the operational area. Whilst we appreciate ultimately being provided access, you will understand that providing entry in a reasonable time frame provides us with greater surety, that site operations have not been altered in the intervening period.

As acknowledgement of the stretch on site resources, no documents were requested to be viewed on this occasion. During our conversation we were informed that a fire over Christmas, at a site to which wastes were destined, had led to an accumulation of waste at this site. As a consequence there was more waste present than there should be. I issued Mr. Jepson with a Code B Notice of Powers & Rights prior to commencing our inspection.

Operations suspended to enable inspection.

Having entered the permitted area and proceeding to the Western side of the main buildings it became evident that there was significantly more waste present than determined in either the EMS (Environment Management System) or approved FPP (Fire Prevention Plan). Waste plastic both loose and bales for reprocessing, covered an area of conservatively 30m x 30m and to a height of 3m (2700m3). [Refer photos 861, 864 & 866]. This is significantly more than the maximum 750m3 recommended in FPP guidance, the 160m3 quoted in your approved FFP and confirmed in your email of 01/04/2019. [Or the 450m3 stated in the FFP Ref: 2019102701 Version: Issue 1, October 2017 which was rejected by ourselves and requires resubmission]

Power lines pass directly over this mass of combustible waste, presenting an additional risk in the event of a fire.

This represents a breach of your Environmental Permit:

2.3.1 For the following activities referenced in schedule 1, Table S1.1, the activities shall, subject to

the conditions of this permit, be operated using the techniques and in the manner described in the documentation specified in schedule 1, table S1.2 unless otherwise agreed in writing by the Environment Agency.

Reason for breach: Waste plastic is stored in an area and in quantity which exceeds volumes stated in both the waste storage section of your EMS, as well as the previously approved FPP (Ref 2015081702).

**CCS Category: Category 2** – A non-compliance which could have a significant environmental effect.

A further mass of finer processed waste up to 8m in height in places was observed to the North of the building currently housing the baler [Refer Photos 889,890,893 & 895]. Again conservatively calculating a block within this mass of 50m x 10m x 4m = 2000m3. These aforementioned masses of waste are separated by a vehicle access route [Refer Photo 875] which does not appear to maintain a full 6m gap. There is therefore the potential for a fire on one side to spread to the adjacent pile.

This too represents a breach of your Environmental Permit:

2.3.1 For the following activities referenced in schedule 1, Table S1.1, the activities shall, subject to the conditions of this permit, be operated using the techniques and in the manner described in the documentation specified in schedule 1, table S1.2 unless otherwise agreed in writing by the Environment Agency.

Reason for breach: Processed waste is stored in an area and in quantity which exceeds volumes stated in both the waste storage section of your EMS, as well as the previously approved FPP (Ref 2015081702).

**CCS Category: Category 2** – A non-compliance which could have a significant environmental effect.

####Please note these are conservative estimates and your records should be able to demonstrate how much waste is present on site at any particular time. A re-visit may be necessary to more accurately assess this, if you do not have your own figures.#####

In addition to the excess quantity of waste material stored, your EMS states that 'Areas used to store processed waste will be cleared completely at the following intervals: One week for combustible materials (e.g. wood, plastics, shredded waste).'

# Criteria: c2 Management System & Operating Procedures

Permit Condition(s) breached: 1.1.1 The Operator shall manage and operate the activities: (a) in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attention of the operator as a result of complaints. . .

Reason for breach: The accumulated masses of waste had clearly been present for longer than the one week specified, including deteriorating bales stored adjacent to the baling line. [Refer Photo 891]. Steam was noted from an isolated area of the processed waste, indicating biodegradation. We were later informed that waste pile temperatures are routinely checked with a probe but the current pile sizes make effective monitoring impossible.

**CCS Category: Category 2** – A non-compliance which could have a significant environmental effect.

We consolidate all non-compliances relating to an individual permit condition. This means that during an assessment we only give a permit holder one category and score per permit condition. So, although three non-compliances have been recorded under permit condition 1.1.1, we consolidate them for the purposes of assessing risk or impact and for scoring.

Intermediate Bulk Containers (containing liquid) labelled as antifreeze and odour neutraliser were present without secondary containment. In addition the fuel dispensing pump trailed outside its containment area with evidence of it having leaked/spilled onto the open yard. [Refer Photos 908 & 909].

# Criteria: b4 Containment of stored materials

Permit Condition(s) breached: 3.1.3 All liquids in containers, whose emissions to water or land could cause pollution, shall be provided with secondary containment, unless the operator has used other appropriate measures to prevent or where that is not practicable, to minimise, leakage and spillage from the primary container.

Reason for breach: Liquids in containers (IBC's) identified without secondary containment or other measures to minimise leakage & spillages.

CCS Category: Category 3 – A non-compliance which could have a minor environmental effect.

Such is the extent of accumulated waste, it has extended beyond the bounds of your permitted area on the Western side. Additionally an area in the South Western corner of the operational site, contains a separate pile of larger pieces of plastic film and bag waste. [Refer Photos 867 & 898].

(Note the soil/waste bund with fencing does not demarcate your permit boundary). You should refer to schedule 7 of your permit which shows its geographical extent.

# Criteria: a1 Specified by permit

Permit Condition(s) breached: 2.2.1 The activities shall not extend beyond the site, being the land shown edged in green marked on the site plan at schedule 7 to this permit.

Reason for breach: waste stored outside permitted area.

CCS Category: Category 3 – A non-compliance which could have a minor environmental effect.

# Minded to serve notice.

In particular in light of the significant excess quantities of combustile waste present and their potential for catching fire, we are minded under the Environmental Permitting (England and Wales) Regulations 2016, to serve a Regulation 36 Notice. This is a notice to take specified steps in

relation to a breach of permit condition(s).

## Other comments.

### Criteria: b1 Engineering for prevention & control of pollution

Large areas of the yard are covered in waste/mud, making an effective assessment of the underlying integrity of the impermeable surface diffcult. Your site sits on a Major Aquifer with High Vulnerbaility making this element of infrastructure particulalry important. Note your EMS states:

3.2.1 The fabric of the existing hard standing areas will be subject to daily inspection during the operation of the facility. Any defects will be recorded in the Site Diary.

### Criteria: d1 Site security

The wider site beyond the active area, was not inspected, so a full assessment of the site security was not undertaken. With sections of the dividing mound and fencing not having been re-instated, access between the two areas is easily undertaken. There is currently an unsecured gap toward the railway line. Due to the curtailed nature of the inspection and not wearing orange reflective jackets, the railway area was only viewed from the edge of the concrete blocks. Some plastics were noted in the trees lining the railway.

As well as offsite, loose waste material was also noted around the cylinder cage. In the event of a fire, this material presents an increased hazard with the potential to heat the cylinders to dangerous levels.

Site security, litter control and general housekeeping will be more closely assessed during our next inspection.
