We believe that Eco-Power Environmental Limited has committed the following offences:

Date: On or before 21st May 2020.

Offence: Failure to comply with an environmental permit condition, namely failure to install a perimeter fence or bund along the southern boundary which is capable of preventing access to the site, as specified in Section 2.1 of your Environment Management System, , in breach of permit condition 1.1.1 of your environmental permit reference EPR/EB3207LH, contrary to Regulation 38(2) of the Environmental Permitting (England and Wales) Regulations 2016

Date: On or before 21st May 2020.

We have issued this **warning letter** as a response to the above offence. Although the facts cause us concern, after consideration, we do not propose taking any further action with respect to the above offence.

However, our decision could change if further relevant information becomes known or further issues arise, such as:

- you have committed earlier offences;
- you continue to commit offences;
- the environmental impacts of the above offence is greater than we presently understand them.

We will take this into account if we consider that you are involved in any future offending.

This warning does not:

- prevent any other prosecuting authority taking action against you; or
- affect our right to issue enforcement, clear-up or remediation notices, or seek recovery of costs or damages.
