

Apprenticeship statistics: August 2020 underlying data

Metadata specification

Description

This document describes the underlying data files accompanying the [Apprenticeships and traineeships: August 2020](#) statistics publication. This data is released under the terms of the [Open Government License](#). It is provided to allow users to interrogate the data themselves.

The underlying data files contain apprenticeship starts figures in England broken down by start month and subject characteristics (e.g. sector subject area, level, framework and standard name).

The [User Guide to Further Education and Skills Statistics](#) published alongside the [Further education and skills: March 2020](#) publication should be referenced alongside this data. It provides information on the data sources, their coverage and quality as well as explaining methodology used in producing the data.

File format

The underlying data contains the following files:

- Unrounded raw data set (framework, standard, SSA, level, age): August 2014 to June 2020, reported to date
- Unrounded raw data set (framework, standard, SSA, level, age): July 2020, reported to date

Note: July apprenticeship starts data at this point in the year need to be treated with caution, please see the caveats in the commentary document on these data and potential for misinterpreting how they may represent the apprenticeship programme as a whole. The data is being released for transparency purposes during the COVID-19 pandemic.

Annex A – Field Listing

A full list of the fields used in the underlying data files is given below:

Variable name	Variable description
Age	Age of the apprentice at the start of the apprenticeship.
Degree apprenticeship	Apprenticeship contains a mandatory degree component that is needed for successful achievement of the apprenticeship.
Detailed Level	Level of the apprenticeship (Level 2; 3; 4; 5; 6; 7).
Framework/Standard Name	The name of the framework or standard.
Framework/Standard Flag	Defines if the apprenticeship is a standard or framework.
Funding Type	Funding source of the apprenticeship (supported by ASA levy funds; Other; Totals).
Level	Apprenticeship level (Intermediate, advanced or higher).
Start	A learner has begun an apprenticeship programme.
Start Month	Month in which a learner began an apprenticeship programme.
Start Month Order	Academic month in numeric form, in which a learner began an apprenticeship programme.
SSA T1	Sector subject area (tier 1) of the apprenticeship standard or framework or learning aim being studied.
SSA T2	The sector subject area (tier 2) of the apprenticeship standard or framework or learning aim being studied.
ST Code	Reference code assigned by the Institute of Apprenticeships to an apprenticeship standard
Year	Academic year
