# REQUEST FOR INFORMATION – INFORMATION RELATING TO THE MURDER OF RUC SGT GORDON WILLIAM WILSON ON 21 FEBRUARY 1983

I can confirm that your request has been considered under the provisions of the Freedom of Information Act 2000 (FOI (A)), and the process is now complete.

You stated the following:

"Information relating to the murder of RUC Sgt Gordon William Wilson at the Albert Bar, Armagh on the 21 February 1983."

I can confirm that the MOD holds some information relating to the murder of Sgt Gordon Wilson. This information has been located in a range of documents and relevant extracts of these have been provided at Annex A.

Some of the information you have requested could be exempt under Section 23(1) of the Freedom of Information Act, which relates to the bodies dealing with security matters, although it is also possible that the information relates to none of the bodies dealing with security matters. Sections 23(1) and 24(1) are being cited in the alternative as it is not appropriate, in the circumstances of the case, to say which of the two exemptions is actually engaged so as not to undermine national security or reveal the extent of any involvement, or not, of the bodies dealing with security matters. Section 23 is an absolute exemption and, if it were engaged in this material, the MOD would not be required to consider whether the public interest favours disclosure of this information.

Any information that is not exempt from disclosure under Section 23(1) could be exempt under Section 24(1) of the FOI(A), which exempts information from disclosure if its exemption is required for the purpose of safeguarding national security. We cannot say which of the two exemptions is actually engaged, but to the extent that S24(1) might be engaged. We acknowledge the public interest in openness and transparency, but we consider that there is a stronger public interest in protecting national security.

All Police Service of Northern Ireland (PSNI) cases remain open and if new evidence comes forward the PSNI will reinvestigate. Release of these documents must be carefully considered under Section 31 (Law Enforcement) of the FOI(A).

I have completed this consideration through a public interest test including consultation with the PSNI who have advised that release of some of the information could adversely impact on any investigative process and may jeopardise any future prosecutorial process. On this basis I am withholding some of the information under Section 31 of the FOI(A).

In addition, some of the information falls within the scope of Section 38 (Health and Safety) of the FOI(A), as its release could endanger the physical or mental health of any individual or endanger the safety of any individual. Section 38 is a qualified exemption and we have conducted a public interest test to determine whether the information should be released or withheld. The factors for this public interest have determined that whilst disclosure would demonstrate openness and transparency this is outweighed by the detrimental effect disclosure could have on those mentioned in the documents, or their family members and friends. I have concluded that whilst disclosure may be of historical interest, the health and safety of individuals must be taken into account. Some information has therefore been redacted under Section 38 of the FOI(A).

Additionally, some of the information contained within the disclosure constitutes personal information, such as names and addresses. Under FOI(A) this information is exempt under Section 40 (2) by reason of the first condition under Section 40 (3) (a) (i), as disclosure would contravene data protection principles under the Data Protection Act 2018 (DPA 2018). This is an absolute exemption and does not require a public interest test to be conducted in order for this information to be exempt from disclosure. Therefore, all personal information has been redacted.

I appreciate that this incident took place 37 years ago and the passage of time can be a factor in diminishing the applicability of exemptions to information. However, in this instance the overall balance is in favour of partial exemption.

# Verbatim Extracts from Various Documents Relating to the Murder of Sgt Gordon William Wilson on 21 February 1983

## Daily Operations Brief - 21-22 Feb 83

#### 8 Inf Bde

At 212024 hrs and RUC DMSU mob ptl stopped to call at a fish and chip shop on LOWER ENGLISH ST, ARMAGH. On returning to the
car an explosion occurred and RUC Sgt Wilson was killed. The explosion demolished one derelict building and broke windows of
nearby buildings.

RUC Sgt Gordon Wilson was killed instantly in Armagh when a radio controlled device estimated at 30 kg of home made explosives initiated in a derelict hurling him across the road (21 Feb)

#### 8 INF BDE 21 Feb 83

- 33. Explosion, Armagh. At 2024 hrs an RUC DMSU ptl car stopped at the junction Lisnally Lane/Lower English St to call at a fish and chip shop. A cover group was deployed. As it was withdrawing an explosion took place at 39 Lower English St, a derelict public house, and Sgt Gordon Wilson was blown across the rd and killed instantly. The derelict was completely destroyed and neighbouring houses were superficially damaged. The device, est at 30 kg of HME, was radio controlled.
- 12. In Armagh on 21 February a RUC Sergeant was killed when a remotely detonated device of approximately 30 kg exploded in a derelict next to a fish and chip shop.

	Wilson received fatal injuries and died immediately, the other members of the patrol were uninjured.

On the 21 Feb 83 at about 2024 hrs an RUC mobile patrol stopped in Lower English Street Armagh close to the junction of Albert Place, Lisnally Lane. The crew dismounted and two members of the patrol took up covering positions whilst the other members went to a chip shop. At about 2026 hrs Sgt GW Wilson [Redacted] left his position at the corner of Albert Place and began to walk back towards his armured (sic) Cortina, as he passed a derelict building (formerly the Albert Hotel), as explosion occurred from within the building which blew Sgt Wilson across the street where he hit a parked vehicle, Sgt Wilson received fatal injuries and died immediately. The remainder of the patrol were uninjured.
