INTRODUCTION

- 1. I am directed by the Secretary of State to draw your attention to the publication of amendments to Approved Document M (access to and use of buildings) 2015 edition, volume 2 buildings others than dwellings
- 2. The amended Approved Documents will come into force on 1st January 2021 in the circumstances set out in the formal notice of approval in Annex [A] to this Circular.
- 3. The purpose of this Circular is to:
- announce the approval and publication of the amendments to the Approved Documents
- draw attention to the transitional provisions for the above changes
- 4. This Circular does not give advice on the technical requirements in the Building Regulations 2010 as these are matters covered by Approved Documents

APPLICATION OF THE APPROVED DOCUMENTS

5. The changes made to the Approved Documents apply only to buildings and building work in England.

TRANSITIONAL ARRANGEMENTS

6. The new approved documents take effect on 1st January 2021 except in respect of work already commenced before that date or in respect of work for which a building notice or initial notice has been given or full plans deposited before that date and provided work commences by 1st March 2021
