FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: EXTREMIST INVESTIGATION.

We refer to your email dated 5 March 2020 to the Ministry of Defence Police which was acknowledged on the same date.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

"Under the 2000 Freedom of Information Act could you please tell me how many individuals have been investigated in your Police Force since 1st January 2015 on the grounds of extremist views, activities or associations?

Please provide:

i) Total number of investigations in each calendar year

ii) The character of views, activities or associations in each case, either in terms of broad ideology or specific organisation (e.g Neo-Nazi, Islamist, Animal Rights extremism, National Front, National Action, IRA, ISIS etc)

iii) Information on the nature of the allegation/offence in each case (e.g swastika tattoo pro-extremist statement, Nazi salute, membership of an organisation etc)

iv) The outcome of each investigation (e.g no further action, Court Martial, disciplinary measures, discharge)"

As advised in our letter dated 31st March we have conducted and considered the Public Interest Test and on this occasion we have determined that the balance to disclose the information outweighs the need to withhold and therefore please see the information below.
