Your request has been handled under the FOIA.

I can confirm that the MoJ holds some of the information that you have requested and I have provided it as attached. Please note that some of the firms in your list were not found in our data – this is confirmed in more detail in the attached spreadsheet. You can find a list of firms with a legal aid contract at https://www.gov.uk/government/publications/directory-of-legal-aid-providers. Firms may not be found because they do not have a legal aid contract, they are not contracted in the category of law enquired about, or because they are known by a different name from the ones you have listed.

We have interpreted your request as relating to legal aid at the 'Civil Representation' tier, as per your request for 'court work'.

Please note these figures show the amount paid to law firms by way of solicitors profit costs. Disbursements (covering third party expenses) and payments for counsel fees are not included, however figures are inclusive of VAT where applicable.

Reading left to right, the table shows the first three categories enquired about, followed by the sums paid for all three combined in the last column, broken down by those firms of solicitors in England and Wales named in your request.

Outside the scope of the Act, we have noted that this is your third such request for information. In the event you intended to continue to seek this information for other/the remaining firms in the UK, it would be more straightforward to ask for this information all at once by way of a single further response, rather than in piecemeal format.
