## RE: Request for Information - RFI3088

Thank you for your recent email, which was processed under the Freedom of Information Act 2000 (FOIA). You requested the following information:

am studying the impact on Wandsworth, in London, by the Help to Buy scheme, in terms of number and sales price of properties sold since the scheme launched in 2013.

I located the data published online July 2020 <a href="https://www.gov.uk/government/statistics/help-to-buy-equity-loan-scheme-statistics-data-to-31-march-2020">https://www.gov.uk/government/statistics/help-to-buy-equity-loan-scheme-statistics-data-to-31-march-2020</a>) and was hoping to cross reference this with the government statistical data published here <a href="https://www.gov.uk/government/statistical-data-sets/price-paid-data-downloads">https://www.gov.uk/government/statistical-data-sets/price-paid-data-downloads</a> for <a href="Wandsworth">Wandsworth</a>, either using postcode or transaction id. I appreciate that detailed postcode might be sensitive but if the data was abridged to show only the first 3 or 4 digits of the postcode e.g. SW12 or SW8, I would be able to make a reasonable approximation. When I emailed the governmental agency which published the Help to Buy information, they told me to contact Homes England directly to request this detail.

We wrote to you to clarify whether you wanted this information for Wandsworth Local Authority area or Wandsworth town and you advised that the information you are seeking is for Wandsworth Local Authority area.

#### Response

We can confirm that we do hold the requested information.

### Number of Sales

The number of sales via postcode (first three or four digits) for the Wandsworth Local Authority area is enclosed as Annex A.

#### Sale price of properties

To release the sale price of individual properties within each postcode area engages S40(2) of the FOIA.

To release the information could lead to identification of individual customer data as the purchase price could be cross-referenced with publicly available information.

Section 40(2) exempts personal information from disclosure if that information relates to someone other than the applicant and if disclosure would breach one or more of the data protection principles in Article 5(1) of the General Data Protection Regulations and section 34(1) of the Data Protection Act 2018.

Section 40 is an absolute exemption which means that we do not need to consider the public interest in disclosure. Once it is established that the information is personal data of a third party and release would breach one or more of the data protection principles, then the exemption is engaged.

We have a duty to provide advice and assistance in accordance with Section 16 of the FOIA and as such we have provided an average purchase price per postcode in Annex A.

### **Right to Appeal**
