The target depth and the projected national grid co-ordinates at the top of each borehole and at intermediate and target depths if they are to be deviated

Any current coal licence areas or past coal mine workings to be intersected by the proposed activities?

Any interaction likely to be caused by the proposed activities with other coal mining operations together with an assessment of the effects

Details of any known abandoned mine outlets on the site

Details of measures that will be taken in any coal mine workings to prevent or remedy spontaneous combustion, uncontrolled emissions of gas or water or any other hazard directly or indirectly caused or related by the proposed activities especially having regard to the potential impact on properties lying within and/or adjacent to the site boundary

The nature of any casing to be used at the coal seam horizons and state whether the intention is to remove it from boreholes on completion Proposals for sealing of boreholes particularly with reference to the coal seam horizons

5. Other necessary rights, permissions or consents obtained

5.1 If the application is for a single site or for a Supplemental Agreement please supply the following information.

Details of the surface landowner(s) for the site and the owner(s), if any, of any other minerals to be intersected not in the ownership of the surface landowner

A web link to planning consent for the proposed operation (or append a copy)

Details of required work programme and the consent to drill the borehole under the petroleum licence (Well Operations Notification System ("WONS") consent)
