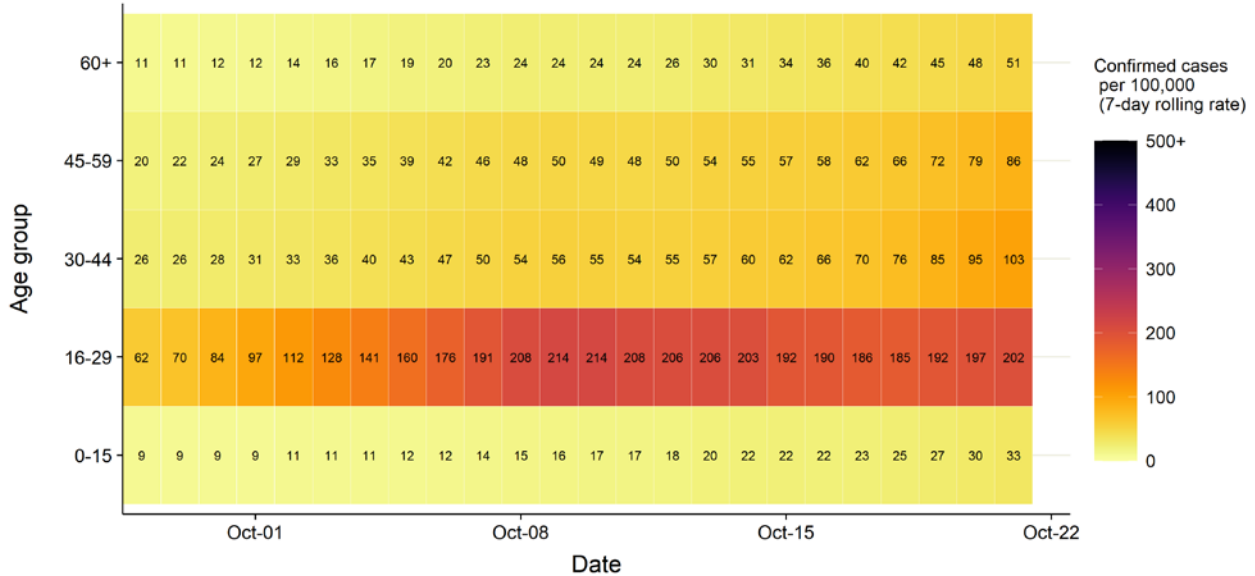

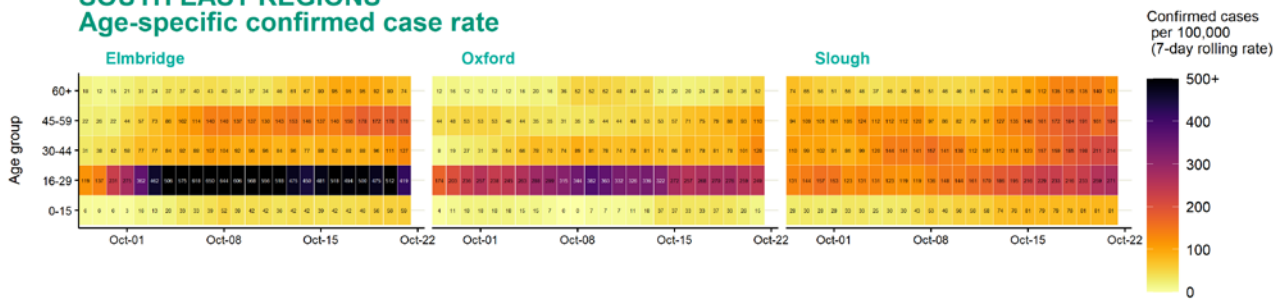
SOUTH EAST Age-specific confirmed case rate

SOUTH EAST REGIONS Age-specific confirmed case rate



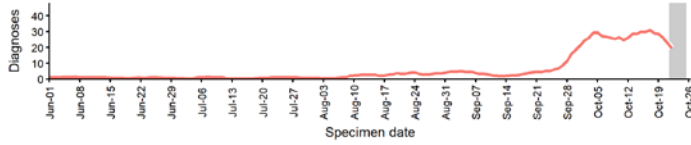

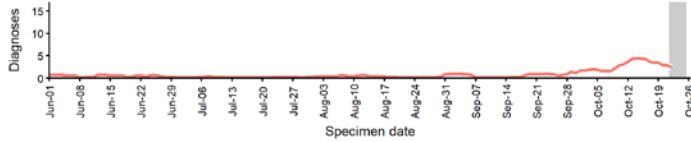

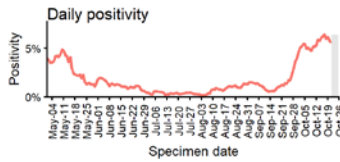
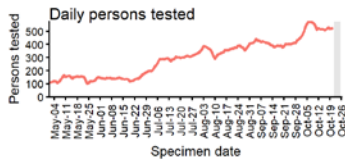
Daily cases by pillar from 1/6/2020: ALL AGES



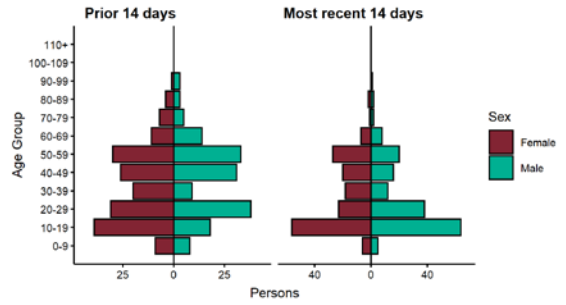
Daily cases by pillar from 1/6/2020: 60+ YEARS ONLY **NOTE: different y-axis scale**

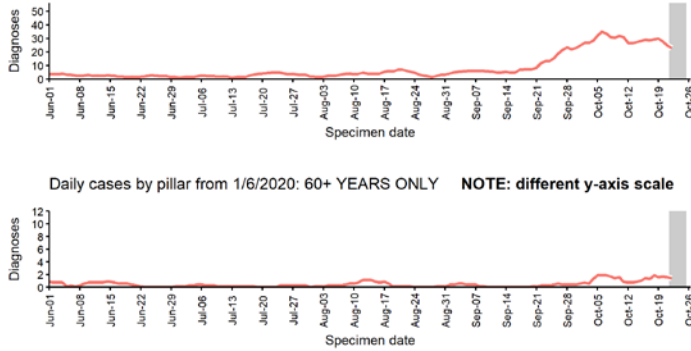

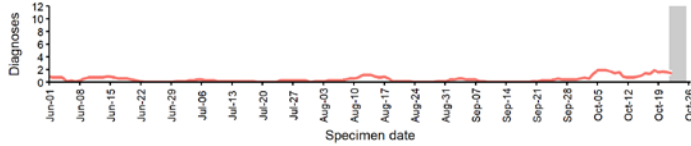

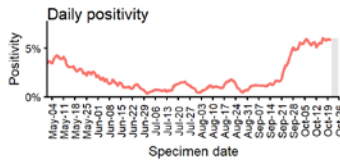
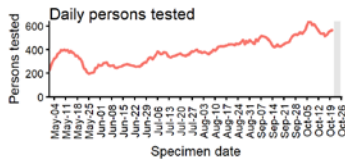
Daily cases by pillar from 1/6/2020: ALL AGES



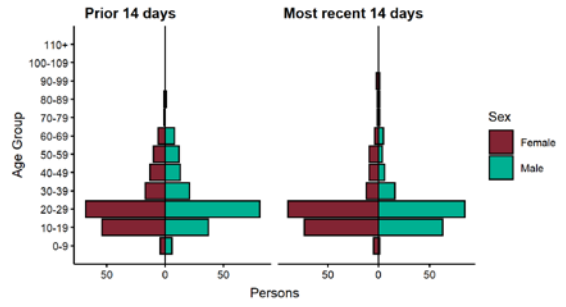

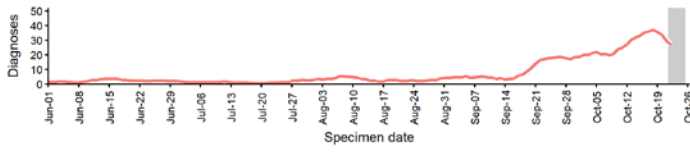

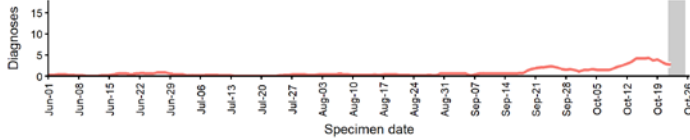

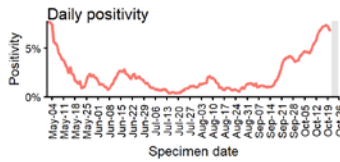
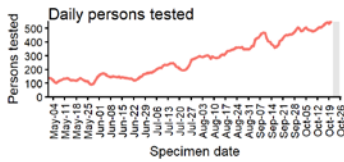
Daily cases by pillar from 1/6/2020: ALL AGES



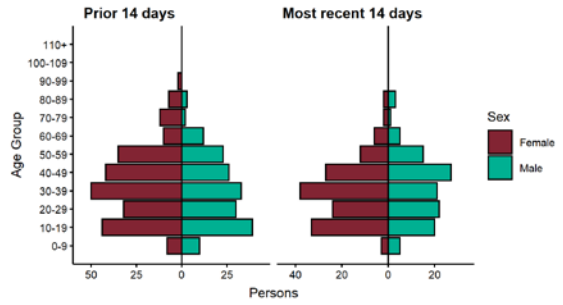
