Freedom of Information Request

I am writing to advise you that we do hold information that is relevant to your request on the 27 October 2020 but regret to inform you of my decision not to disclose this information.

The information you requested is being withheld in reliance on the exemption in section 22 https://www.legislation.gov.uk/ukpga/2000/36/section/22 of the Freedom of Information Act 2000 because the data you have requested has not yet been published.

In applying this exemption we have had to balance the public interest in withholding the information against the public interest in disclosure. Following this test it was concluded that because the analysis on the recently released 2019 Stats 19 data has yet to be completed and verified, and that the 2019 data will be published in the future, releasing the 2019 data now is not in the public interest. The reasoning for this was that the current data may be subject to change or be updated during the analysis process and be misrepresentative if issued now. This would mean further resources would have be spent explaining the differences between the finalised data and the data held now if it was released before the official publication date.

Highways England responds to requests for collision data using validated STATS19 data, which forms part of the National Statistics. Stats19 data records personal injury accidents on public roads but does not indicate which incidents have been attended by Highways England's Traffic Officer Service.

Please see the tables below for the latest data for collision's mapped to the Highways England Strategic Road Network in **2018**.
