Please could you break down the numbers by weekly periods, if possible.

2) Please could you reveal how many people have been charged with the offence of "Revenge Porn" since the 23rd March 2020. Please break down this figure to show how many people received cautions.

3) Please could you break down the victims of "revenge porn" since the 23rd March 2020 by gender and into the following age groups 0-9, 10-19, 20-29, 30-39, 40-49, 50-59 and 60+.

4) Please could you provide how many crime reports of "revenge porn" or "image based sexual abuse" or "intimate image abuse" (distributing private sexual image of someone without their consent and with the intention of causing them distress) have been made in the same complete period as you are able provide for (1) for the years 2019, 2018 and 2017. Please could you break down the victims of "revenge porn" during these periods by gender and into the following age groups 0-9, 10-19, 20-29, 30-39, 40-49, 50-59 and 60+.

5) Please could you provide how many crime reports of "revenge porn" or "image based sexual abuse" or "intimate image abuse" (distributing private sexual image of someone without their consent and with the intention of causing them distress) have been made in the last 5 years, broken down by year."
