FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: HATE CRIMES OVER A 20 YEAR PERIOD.

We refer to your email dated 25 June 2020 to the Ministry of Defence Police which was acknowledged on 26 June 2020.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

- "1. The total number of reported hate-crimes in your Constabulary each year from January 1st 2000 to June 1st 2020
- 2. From those cases above, how many resulted in a conviction?
- 3. Out of these hate-crimes, do you have statistics on how many were incidents of racism? If so, can this figure be included for each month?"

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

NB: For this question we have taken Hate Crimes to mean any crime involving the 5 protected characteristics – disability, transgender status, race, religion, sexual orientation.
