We refer to your email dated 2 July 2020 to the Ministry of Defence Police which was acknowledged on the same date.

- “1. Please provide data on the number of times officers in your force have used Tasers on children aged 17 years old and younger.**
- 2. Please can this be broken down by year (i) 2017, (ii) 2018, (iii) 2019, and (iv) 2020, to date**
- 3. Please can this data be further broken down by:
(a) age; (b) ethnicity; (c) category of highest use (i.e. Drawn, Aimed, Arched, Red Dotted, Drive Stun, Angled Drive Stun and Fired); (d) reason for use; and (e) location of use (i.e. in police custody, in public, etc)”**
