
Monthly Summary


- 1.1.1 This Summary Report is published in fulfilment of commitments detailed in the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, Annex 1: Code of Construction Practice, for the nominated undertaker to present the results of air quality and dust monitoring undertaken in the London Borough of Ealing (LBE) during August and September 2020 respectively.
- 1.1.2 Figure 1 and Figure 2 in Appendix A indicate the current worksites together with air quality and dust monitoring locations.
- 1.1.3 This summary should be read in conjunction with the overview monitoring report available from www.gov.uk/government/collections/monitoring-the-environmental-effects-of-hs2, which highlights: the applicable standards and guidance, as well as the air quality and dust monitoring methodologies to be implemented by nominated undertakers throughout construction.
- 1.1.4 The current phase of construction works commenced in October 2019 and is expected to be completed by 2025. The current worksites, as presented in Appendix A, Figure 1 and Figure 2, include:
 - Old Oak Common Depot (located in the London Borough of Hammersmith and Fulham) mobilisation and new site set up for the station works contractors;
 - Victoria Road Crossover Box and Flat Iron Site –groundworks and utilities;
 - Willesden Euro Terminal –groundworks;
 - Atlas Road
 – site set up and groundworks;
 - Green Park Way Vent Shaft mobilisation and site set up; and
 - Mandeville Road Vent Shaft mobilisation and site set up.
- 1.1.5 Eleven (11) dust monitors were installed around worksites, where works are underway. These sites returned a medium dust risk rating.
- 1.1.6 Dust monitoring locations and results are presented in Appendix B, Table 1, together with line charts of monthly data from each dust monitor in Figure 3. All continuous dust monitoring is undertaken using indicative monitors. Despite being Environment Agency (MCERTS) certified, indicative monitors carry a higher level of uncertainty than reference monitors, and therefore cannot be strictly compared with Air Quality Standards for human health and the environment. The purpose of the monitoring undertaken is to ensure the effectiveness of the on-site mitigation.
- 1.1.7 The trigger level for PM_{10} concentrations of 190 μ g/m³, over a 1-hour period, in accordance with the updated guidance document 'Guidance on Monitoring in the Vicinity of Demolition and Construction Sites (October 2018)' has been applied.

- 1.1.8 There were no (0) dust trigger alerts recorded during the monitoring period (September 2020). All results were in line with expected ranges.
- 1.1.9 Data capture for monitors AQ037 and AQ038 was below 90% for the month of September 2020. This was due to loss of power to the monitor AQ037 and the removal of monitor AQ038 for calibration (86.7% and 81.0% respectively).
- 1.1.10 Diffusion tube monitoring of Nitrogen Dioxide (NO₂) is undertaken at six (6) locations around highways within the LBE as part of the management of air quality where significant effects may occur as a result of the scheme.
- 1.1.11 Diffusion tube monitoring results are provided from the laboratory analysis, and therefore still require various analysis and adjustments to be undertaken. Final corrected results will be presented and described in the annual report. However, based on the results to date, no unexpected values were recorded during the monitoring period.
- 1.1.12 NO₂ monitoring locations and results are presented in Appendix C, Table 2, together with the 2020 running mean.
- 1.1.13 There were no (0) complaints received, relating to dust or air quality, during this reporting period (September 2020).

Figure 1 and 2: Worksites and monitoring locations within the LBE









