# Project: Whether to approve the transfer of The Levels Academy Trust, Somerset to Preston Primary Academy Trust

#### HTB discussion:

- The historic and ongoing concerns about The Levels Academy Trust's (TLAT) educational performance, school improvement capacity, governance and long term viability
- Preston Primary Academy Trust (PPAT) is local to TLAT and is providing support to TLAT ahead of the prospective transfer
- PPAT has a strong track record of school improvement
- PPAT should continue to review governance structures in light of growth
- RSC recommended PPAT conduct an external review of governance in 2021 and implement findings before further growth applications
- PPAT is encouraged to continue sharing expertise and linking up with other MATs
- HTB members are supportive of the transfer

# **Converter academy orders**

Project: Whether to approve Plymouth High School for Girls, Plymouth converting to academy status and joining The Thinking Schools Academy Trust, Kent

#### HTB discussion:

- The Thinking Schools Academy Trust (TSAT) is a trust in Kent with strong outcomes and a track record of school improvement
- TSAT has previous experience of working in the South West region, therefore cognisant of some of the challenges in the region
- There is a risk of sustainability with TSAT's hub in Plymouth only having one school, this is being carefully managed by the trust
- The trust need to ensure that there is sufficient separation between Trust Board and Academy Advisory Board members

Project: Whether to approve Thorncombe, St. Mary's Church of England Voluntary Controlled Primary School, Dorset converting to academy status and joining Acorn Multi Academy Trust

#### HTB discussion:

- Thorncombe has been working with Acorn for the past two academic years in a successful management partnership after it was judged RI in 2018
- Acorn MAT has been providing school improvement, governance and finance support to the school
- The school and trust now want to formalise their partnership through the conversion route to ensure the school's sustainability
- Dorset Local Authority and the Diocese of Bath and Wells support the proposal
- There is a risk around school viability in light of the declining pupil numbers at Thorncombe
  but this is being carefully managed and addressed by the school and trust. This will need to
  be monitored carefully
- Acorn MAT's school improvement capacity and actions which need to be taken by the trust to ensure future sustainability
- Acorn to ensure that their governance structures are compliant

RSC decision: Approve with the following conditions:

- That the trust commit to work with the RSC office to secure its long-term future through joining another trust.
- The trust conduct an external review of governance and share the outcome with the RSC office prior to transfer.
