Dear Mr Thank you for your email of 9 October 2020 to the Ministry of Defence (MOD) requesting

the following information:

"Please could I obtain a copy of all payments between the MOD and the University of York Students Union (yusu.org), as well as payments to the University of York (york.ac.uk) - this is specifically for recruitment purposes such as payments to appear at freshers fair/on campus.

The scope of the request is all payments (and payments agreed to / accepted but not yet invoiced) from 2017 to today."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence and I can confirm that all the information in scope of your request is held.

I can confirm that since January 2017, there has been one payment between the MOD and the University of York Students Union which was for a stand to appear at a freshers fair. The details of which can be found within the attached Annex.

There have been no payments between the MOD and the University of York since January 2017.
