Reason for change (including benefits)

The introduction of CIN plan dates is to help the department understand the journey of the child following a referral to local authority children's social care. The CIN plan sets out which

organisations and agencies will provide which services to the child and family. The plan should set clear measurable outcomes for the child and expectations for the parents.

Section 2 – impact analysis

Software suppliers' summary of impact assessment

Supplier 1: We believe that we would need additional clarification in terms of how these dates could be identified, to ensure that we could provide a single solution for our customer base. Following internal discussions we have made the following assumptions:

The CIN Plan start date could easily be identified as the first occurrence of the "CIN Plan" within the workflow.

However we have some uncertainty about how you would expect the CIN Plan End Date to be derived and how this would differ to the CIN Closure Date. We believe that the following logic could be used but would welcome clarification:

- When a child transitions from a CIN Plan to a Child Protection Plan the start date of the CPP could be used as the CIN plan End Date
- When a child becomes looked after the Period of Care Start Date could be used as the CIN plan End Date
- When the child is closed immediately after a CIN Plan End Date the date the decision to close could be used as the CIN Plan End Date.

We believe that the introduction of these two data items could potentially cause a lot of variance within our customer base as to how they are identified without the introduction of very tight guidance as to how they should be identified.

Supplier 2: Please note that the CIN plan gets updated after each review, so this could be every few months. Guidance would need to be clear about whether you want every update of the plan or whether there's another criteria.
