Authorized Amendment

The new 1160 Series RA's provide a revised Air Safety governance framework for activity within the Defence Air Environment, tailoring the specifics of these governance arrangements to 5 new Operating Categories. The developments have also resulted in changes to the military registration process, Certificate of Usage, the roles and responsibilities of an Air System's Sponsor, the important introduction of a Type Airworthiness Manager (the ability to delegate (some) TAw management accountability to an Industry nominated individual) and the introduction of a new RA 1305 for Civilian Operated Military Permits to Fly.
