As part of the review work to update and improve the 5000 series (MAA/RN/2020/02 refers) the 5800 series of regulations have been updated to align with EASA Part 21 where appropriate and to improve coherency and consistency with use of terminology and to prepare for the subsequent publication of the Manual of Military Air System Certification (MMAC).

The requirements of the Regulations have not fundamentally changed but the Regulations have been amended to achieve greater alignment with EASA Part 21 regulations. Additionally, where

appropriate, non-regulatory process and Guidance Material has been removed. As such the impact to the TAA, Commodity DTL and supporting DOs will be minimal necessitating at most only administrative updates of documentation.
