Authorized Amendment

The Regulated Community is reminded to check this amendment against any applicable AAMC, Waivers or Exemptions to ensure their ongoing validity.

RA 1010 - Head of Establishment – Aviation Responsibilities: this is a new Regulation for Head of Establishment. Whilst working on the amended RA 1026 it became apparent that an RA for HoE was required especially with the frequency at which HoE is referred to within the MRP. The RA includes the introduction of a 'Classification Tier of Base, Site, Establishment or Building'.

RA 1026 – Aerodrome Operator and Aerodrome Supervisor (Recreational Flying) Roles and Responsibilities including Aerodrome and Helicopter Landing Site Assurance Requirements. This Regulation has undergone a significant amendment and you are advised to read the RA alongside the new RA 1010. The RA no longer focuses just on Aerodrome Operators and now

covers non-MOD Aerodromes and recreational flying, introducing the use of a Aviation Safe Operating Environment Manual and the appointment of an Aerodrome Supervisor (Recreational Flying) when applicable.

RA 1030 - Defence Aeronautical Information Management. This is a new Regulation which identifies the roles and responsibilities of those parties responsible for developing and maintaining Aeronautical Information (AI) Policy, and for the origination, management, publication and assurance of AI to ensure Aviation RtL is minimised.

Defence Aerodrome Manual (DAM) – This Manual has been amended to bring it in line with the Mil AIP so it is easier for the Regulated Community (RC) to cross-reference the two documents. It has also been condensed so it flows logically. This NAA includes a reference table to show where the changes have taken place.

Defence Aerodrome Assurance Framework – This has been amended to fit Issue 7 of the DAM.

Aviation Safe Operating Environment Manual (ASOEM) – This is a new Manual and is a scaled-down version of the DAM. It is for use at non-MOD aerodromes, Helicopter Landing Sites or when recreational flying is the sole activity at MOD aerodromes. The RC should refer to Issue 5 of RA 1026 – Aerodrome Operator and Aerodrome Supervisor (Recreational Flying) Roles and Responsibilities including Aerodrome and Helicopter Landing Site Assurance Requirements.
