

Thank you for your letter dated 4 March 2020 requesting the following information:

"How many animals were killed at Porton Down in 2019"

We are treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

We were not in receipt of your letter dated 22 February 2020. However, we are in receipt of your subsequent letter dated 4 March 2020.

A search for the information has now been completed within the Ministry of Defence, and I can confirm that all the information in scope of your request is held.

The information you have requested can be found below.

In 2019, 1490 animals were used in regulated procedures under the Animals (Scientific Procedures) Act 1986 at Dstl Porton Down. During the procedures the animals survived, were euthanased at a humane endpoint or died. At the end of the procedures all animals remaining alive were humanely euthanased. Therefore, the total number of animals killed as a result of regulated procedures is the same as the number of animals used, ie. 1490.

Under Section 16 (Advice and Assistance), the UK and its Armed Forces are entitled to safe and effective protective measures. Part of Dstl's role is in providing the very best protection including where that can, currently, only be achieved with animal experiments. Animals are used in experiments to develop new vaccines, therapies and treatments that save the lives of UK military. The results of this research also benefit UK civilians and those in parts of the world where certain infectious diseases are endemic. It is MOD policy that all medicines that could be given to service personnel are licensed in the same way as any new pharmaceutical drug. Animal data to demonstrate that the medicines are safe and effective are required as part of all medicines licensure. All research involving the use of animals in experiments is regulated by the Home Office in accordance with the Animals (Scientific Procedures) Act (ASPA). Home Office Inspectors have full access to all Dstl animal facilities and make announced and unannounced visits throughout the year. It is important to note that the Home Office does not grant licences for the development or testing of any offensive weapons and Dstl does not use animals in experiments for this purpose.

Dstl minimises wherever possible the use of animals and uses less than half of one per cent of the total annual animal usage reported to the Home Office for Great Britain.
