Thank you for your email of 5 June 2020 requesting the following information:

"Can you please provide me with any information about DSTL's deployment of civilians to operational theatres? For example:

- Does DSTL have a support to operations team? If so, what is the size of this team and how does it operate? Is it separate to the Stabilisation Unit's Deployable Civilian Expert roster?

- How many DSTL employees have been deployed on operations each year from 2014 to present"?

We are treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that information, in scope of your request is held.

The information you have requested can be found below.

Dstl has teams that coordinate its support to operations, including preparing staff for and supporting them on deployment and responding to requests for support through reachback into Dstl. Deployed staff are drawn from across Dstl according to the nature of the support required.

The team is separate to the Stabilisation Unit's Deployable Civilian Expert roster; Dstl support to operations is both governed and funded separately.

Across all operational theatres currently supported, the following numbers of staff have been deployed for tours of duty on operations overseas:

Table provides number of staff deployed in each financial year from 2014 to 2019.

Financial year 2014-15	41 staff deployed each for part of the year
Financial year 2015-16	0 staff deployed each for part of the year
Financial year 2016-17	2 staff deployed each for part of the year

Financial year 2017-18	8 staff deployed each for part of the year
Financial year 2018-19	4 staff deployed each for part of the year
Financial year 2019-20	2 staff deployed each for part of the year

Under Section 16 of the Act (Advice and Assistance) our response covers only Dstl civilian support to operations.
