Response

We can confirm that we do hold some of the requested information. We will address each of your points in turn.

I understand the above mentioned scheme has now been extended until the end of 2020.

We can advise that the Voluntary Right to Buy (VRTB) scheme closed on the 31 March 2020. Due to the impact of the Covid-19 pandemic, a number of already progressing applications were allowed to continue past this date.

Can you give me to date the number of applicants by housing association who were given a unique reference number,

I am able to confirm that Homes England does not hold the information detailed in your request. This is because there is no business reason for Homes England to do so.

In order to conclude that the information is not held, we have searched with our VRTB team who would have the requested information if held.

Porting is offered to all unable to purchase their home property as part of the VRTB Midland pilot process. Information held on porting is detailed in Table A: Termination Reasons.
