Data for 2017/18 and 2018/19

We can confirm that Homes England does not hold the information detailed in your request.

Advice and Assistance

We have a duty to provide advice and assistance in accordance with Section 16 of the FOIA. To comply with this duty we are able to advise that Homes England underwent significant structural change in 2019. Our Learning and Development team was not established until 2018. Therefore, we do not hold this data until 2019/20.

Data for 2019/20

- The amount spent through the Civil Service Learning (CSL) contract was £51,920. The amount spent through other contracts was £67,136.
- The breakdown of amount spent through the CSL contract on online vs in-person is provided in the attached Annex A. There was no spend for 'off-the-shelf' bespoke training.
