	held virtual hearings in July and virtual/hybrid hearings in September and is expected to complete its public hearings on 23 September (see slide pack for further information).
	HS2 Ltd noted that, of the 36 petitions submitted against the Bill, just 15 (42%) appeared before the Select Committee, with HS2 Ltd having settled the remainder or the petitioner having either decided not to appear or to withdraw their petition.
	The next step is for the Select Committee to publish its report. The Government will respond to the report in due course, in advance of Third Reading. Royal Assent is expected in late 2020.

	HS2 Ltd provided an update on three key areas: Strategic activity, Communities and Looking ahead.

	HS2 Ltd will continue with its virtual online series of engagement events, firstly with the CEF/BLEF and then followed up by Skills, Education and Employment and finally the roll out of Land and Property schemes to the public.
	HS2 Ltd emphasised that they will be supporting Balfour Beatty in their

	engagement with the communities that HS2 work with for upcoming ground investigations.	
	HS2 Ltd informed members that they will be managing community expectations, particularly informing communities that they will see a phased approach to construction work: it will not be shovels in the ground from day one.	
	Action: SCC requested a meeting with HS2 Ltd regarding a Parish Council's representation.	HS2 Ltd
	The Chair queried whether Parish Councils and other stakeholder groups were up to speed with virtual meeting and expressed that HS2 Ltd may want to consider how and if local authorities could do more to support communities to engage.	
	NUL queried if the general public could attend the events or would they be required to be involved with their Parish Council to obtain access. HS2 Ltd explained that invites to Parish Councils have been specifically for Parish Councils. However, some events are open access public events where anyone can attend, for example archaeology, ecology or CEF/BLEF sessions.	
	NUL inquired if HS2 Ltd kept records of all the steps that have taken to engage with communities and will this be reflected in the feedback following engagement events. HS2 Ltd confirmed that evidence of engagement was recorded and utilised to improve engagement. HS2 Ltd also explained that feedback sessions would be taking place and that virtual engagement has been an iterative process following each engagement event. Furthermore, it was stressed that HS2 Ltd had and will continue to take as many steps as practically possible to ensure active engagement in the project. It was noted that procedures normally implemented for public events had been employed alongside the Commonplace portal, websites, magazine etc.	
	The Chair recognised the importance of keeping the community up to date and engaged. It was explained that previous major infrastructure projects have been criticised for a lack of engagement with communities 'feeling forgot', between authorisation of the project and the start of work when little appears to be happening.	
	HS2 Ltd agreed with the comments and noted that HS2 Ltd will be working with communities to prepare them for what is to come.

5	Class Approval - update	
	The DfT provided an overview of the statutory process in relation to the Class Approval and what members were to expect (see slide pack for more details). It was noted that due to COVID-19, the department cannot receive signed paper copies so only emails will be accepted.	
	SBC queried whether members of the Forum would receive the notification, or would it just be Chief Executives?	
	The DfT and HS2 Ltd confirmed that all members would be copied into the email, to ensure that everyone is made aware at the same time.

6	Planning Forum Notes - updates	
	HS2 Ltd provided a brief update on the status of the Planning Forum Notes (PFNs), especially in light of the recent Court of Appeal decision on an appeal by LB Hillingdon on Schedule 17 request.	
	It was explained that HS2 Ltd have taken a decision to put all future PFNs on hold, whilst they work through how the Appeal decision may alter their approach to Schedule 17 moving forward. However, it was explained that once the statutory guidance has been issued by DfT then HS2 Ltd would be working with members to explore how any changes would work in practice.	
7	Court of Appeal judgement	
	HS2 Ltd provided an overview of the Court of Appeal judgment for Colne Valley wetlands which related to a Phase 1 Sch 17 appeal decision. It was explained that HS2 will respect the judgement and highlighted that the outcome of the judgement will change ways of working.	
	HS2 Ltd outlined that the HS2 planning regime and EMRs was set up on HS2 to operate in the same way has the Channel Tunnel Rail Link and Crossrail. Essentially this regime allows local planning authorities to make decisions on Schedule 17 planning submissions without some information,	

such as archaeology surveys, because there is already a legal protection in place though the EMRs.

The appeal decision changes the above emphasis and permits local planning authorities to request that eg survey information is made available at the point of decision, rather than relying on the EMRs. However, the practical reality of how this will work is still being determined.

HS2 Ltd drew attention to paragraph 11 of the judgement, which highlights that the HS2 planning regime is still considered to be a streamlined planning process which requires collaboration between parties. As such there is more continuity than change as a result of the appeal.

HS2 Ltd explained that the next steps will be for the Department for Transport to update the Statutory Guidance. It is hoped that this will address any ambiguities and provide a clear position on the practicalities of the outcome. As a result, some Planning Forum Notes may need to be updated in collaboration with the Planning Forum.

In the interim HS2 Ltd explained that pre-application discussions will continue to operate in line with the currently agreed Planning Forum Notes. However if local planning authorities feel that further information is needed, this should be flagged at the earliest opportunity. The need and relevance of the information will need to be discussed on a case by case basis. It was also confirmed that in the Project's view, the judgement does not introduce a validation process.

The DfT added that they are working through the statutory guidance on Phase 1 to clarify timings and the information required to support Schedule 17 applications. It was made clear that the Secretary of State (SoS) does not believe that the judgement creates a validation requirement to trigger the 8-week determination period. Therefore, the 8-week determination for requests for approval begins from the time the determining authority receives the Schedule 17 application and not from the date the determining authority believes an application is complete.

The DfT explained that it was expected that HS2 Ltd and the planning authorities will work proactively and collaboratively to identify what information is required (as far in advance as possible) and what is reasonably required in order for the authority to determine the Schedule 17 application.

The DfT reiterated that the SoS still had the power to determine Schedule 17 applications, in circumstances where there is a dispute between HS2 Ltd and the planning authority.

	NUL explained that local validation requirements throw up lots of issues

	HS2 Ltd explained that there is no validation process associated with the	
	Phase 2a Bill unlike the Town and Country Planning Act (TCPA), therefore	
	Schedule 17 requests become live from the point of submission.	
	HS2 Ltd also explained that as the primary consent was granted by	
	Parliament at Royal Assent, Schedule 17 applications are not applications	
	for planning permission. As such, the TCPA validation stage does not apply,	
	as the planning regime associated with the Bill is bespoke with defined	
	matters for approval and defined grounds in which local planning	
	authorities can consider them. It was recommended that members review	
	the PFNs for context and as a starting point as to how the regime works in	
	practice.	
	HS2 Ltd reminded members that in the Planning Memorandum there is an	
	obligation on HS2 to enter pre-submission engagement with local	
	authorities. It is at this stage when HS2 expects discussions regarding	
	requests for additional information to be raised.
