The High Speed (West Midlands to Crewe) Bill


The High Speed (West Midlands to Crewe) Bill - House of Lords

- The House of Lords Select Committee published its Special Report on the Bill on 19 October
 (http://committees.parliament.uk/committee/404/high-speed-rail-west-midlands-crewe-bill-select-committee-lords/news/120165/hs2-bill-committee-publishes-report/).
- The Government published its response to the Select Committee report on 23 November (http://www.gov.uk/government/publications/hs2-phase-2a-promoters-response-to-lords-select-committees-special-report).
- On 24 November the Government published a Statement of Reasons Command Paper, setting out an overview of the case for the scheme
 and its environmental impacts (http://www.gov.uk/government/speeches/statement-of-reasons-command-paper-for-the-high-speed-rail-west-midlands-to-crewe-bill). The Command Paper is required by Standing Orders to be published at least a week in advance of Third
 Reading of the Bill in each House. The Command Paper is an updated version of the Command Paper published in advance of Third
 Reading in the House of Commons in June 2019.
- The Bill was considered in Grand Committee on 9 & 12 November. No amendments to the Bill were made.
- The Bill will now continue through its remaining 'normal' public Bill stages in the House of Lords Report and Third Reading*.
- Report stage will take place on 30 November.
- No date has yet been fixed for Third Reading; there has to be a minimum period of a week between Report and Third Reading, so the earliest possible date is 7 December.
- After Third Reading, the Bill will return to the House of Commons for one final stage Commons Consideration of Lords Amendments
 (where the House of Commons considers amendments to the Bill made in the Lords, often referred to as 'ping-pong').
- Royal Assent is expected in late 2020*


Construction programme (EEW) update

HS2 Phase 2a Schedule 17 Statutory Guidance



Moving Britain Ahead December 20



Key changes include...

- Local Planning Authorities must not replicate controls in the EMRs unless they are relevant to the grounds for approval and necessary to give effect to their duties under the Schedule (para 21)
- ▶ The interpretation of 'other earthworks' and 'anything in the nature of plant and machinery' (paras 22-23)
- What information may be requested for LPAs to determine an application. The information should be relevant to their duties under Schedule 17 (paras 25-34; Annex 1)
- Approvals, modifications, conditions and refusals by the Local Planning Authority must be justified in relation to the relevant grounds as specified in Schedule 17 (paras 38-48).
- ▶ What modifications and conditions can be made by the LPA under paragraph 6 (paras 49-50)



- The justification for refusal to a submitted scheme where modifications are sought must relate to the relevant grounds (para 56)
- If conditions are sought by a LPA on an approval, the onus is on them to show that the conditions are justified and relevant to the grounds (para 62)
- Schedule 17 does not allow for Grampian conditions (para 63)
- ▶ Highlights the importance of collaboration between HS2 Ltd and LPAs (para 64-65)
- Reiterates that there is no process of validation as that under the Town and Country Planning Act 1990 (para 66s and 68)
- ▶ The date from when the eight-week determination period starts from when the request is received by the LPA (para 67)
- ▶ Requests for additional information from HS2 Ltd after applications have been made to the LPA should only be made in exceptional circumstances (para 69)



What does this mean?

- ▶ The Court of Appeal judgment does not create a validation regime.
- ▶ The Statutory Guidance has always been clear that Schedule 17 does not contain such a system, in clear contrast to the Town & Country Planning Act 1990 where it is expressly written into the Act.
- ▶ The Court of Appeal stated that HS2 Ltd must provide enough information for the LPA to make the decision.
- It also stated that if the LPA does not have the necessary information, it is not obliged to take a decision.
- ▶ However, the ruling said nothing to constrain HS2 Ltd's right to launch an appeal in the absence of a decision.
- It therefore follows that if there is a dispute regarding whether sufficient information has been provided to support an application, then this is properly something which can be determined by an independent Inspector/the Secretaries of State.
- ▶ This is what happened in relation to HS2 Appeal no. 7 in relation to the Colne Valley viaduct.
