- if the authority was a party to the proceedings, a copy of any other final order relating to the child that has effect and, if available, a copy of any maintenance agreement or maintenance award relating to the child;
- if the authority was a party to the proceedings, a copy of any final order relating to a full, half or step brother or sister of the child that has effect.
