Thank you for your email of 15 November 2020 requesting the following information:

***"I would like to make a request for a pdf copy of the latest jsp 768 defence clothing catalogue.***

***If I cannot have the full copy as it is large I would request the introduction section and the parade and ceremonial section"***

You kindly clarified your request in your email of 9 December 2020, as follows:

***"I'd like the current copy of defence clothing catalogue please"***

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that some information in scope of your request is held.

The information you have requested can be found below and attached, but some of the information falls entirely within the scope of the absolute exemptions provided for at section 40 (Personal Data) of the FOIA and has been redacted.

Section 40(2) has been applied to some of the information in order to protect personal information as governed by the Data Protection Act 1998. Section 40 is an absolute

exemption and there is therefore no requirement to consider the public interest in making a decision to withhold the information.

The Introduction section is, as follows:

#### *Clothing Catalogue*

*The Clothing Catalogue provides access to all other clothing items procured, stored and distributed by the Team Leidos. The Clothing Catalogue is split into three distinct sections:*

- *Combat Clothing*
- *Workwear and Personal Protective Equipment*
- *Parade and Ceremonial*

The remainder of the catalogue is attached.

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that the Defence Clothing Catalogue is a living document subject to change as required.
