RECTIFICATION AND MODIFICATION OF SCHEDULES

SCHEDULE XIX - UNITED KINGDOM

Addendum

The following communication, dated 10 December 2020, is being circulated at the request of the delegation of the United Kingdom.

The United Kingdom has examined questions and observations by WTO Members concerning the draft version of Schedule XIX - United Kingdom, as circulated in document G/MA/TAR/RS/570 and G/MA/TAR/RS/570/Add.1. In addition, the United Kingdom has noted technical changes which have been made to Schedule CLXXV – European Union (EU28) in the process of its ongoing certification.¹ Accordingly, the Annex to this communication contains a list of technical rectifications to draft Schedule XIX – United Kingdom.²

The Annex contains those technical changes which the United Kingdom considers should be made most promptly to give clarity to other Members. In due course, a further addendum reflecting changes arising from technical changes to Schedule CLXXV – European Union (EU28) in the process of its ongoing certification will be notified, as well as any other such appropriate adjustments arising from discussions on the UK's schedule, including those that may arise from negotiations under Article XXVIII of GATT 1994.

If no objection is notified to the Secretariat within three months from the date of this document, the rectifications and modifications to Schedule XIX – United Kingdom will be deemed to be approved and will be formally certified.

1 CHANGES TO PART I OF THE SCHEDULE

1.1 Changes to Part I – Section I-B

1. Part I - Section I-B, p. 122 in G/MA/TAR/RS/570.pdf: Correct the text of "Other terms and conditions" (column 4) for the tariff quota with product description "Meat of bovine animals, fresh, chilled or frozen Edible offal of bovine animals, fresh, chilled or frozen" as indicated in the table below. In the initial submission the description erroneously indicated a country volume allocation of 289t to Paraguay. This was due to a clerical error and is corrected as shown in the table below.

The volume indicated in column 3 "Quota quantity and in-quota tariff rate" is corrected accordingly. The corrected total quantity is 5,030 tonnes (product weight).

2. Part I - Section I-B, p. 127 in G/MA/TAR/RS/570.pdf: Correct the text of "Other terms and conditions" (column 4) for the tariff quota with product description "Meat of sheep or goats, fresh, chilled or frozen" as indicated in the table below. In the initial submission, the description indicates that the volume country allocated to New Zealand is of 114,138 tonnes. Following the successful conclusion of the negotiations between the European Union and New Zealand on compensatory adjustments following the European Union's enlargement to include Croatia (see G/SECRET/35/Add.2), the UK apportionment² of New Zealand's country allocation is increased by 67 tonnes, raising it to 114,205 tonnes.

Also, in the initial submission, the description does not include the country allocation to North Macedonia and the corresponding volume apportioned to the UK, which is 905 tonnes.

The volume indicated in column 3 "Quota quantity and in-quota tariff rate" is corrected accordingly. The total quota quantity is 138,631 tonnes (carcass weight).
