HTB discussion: A 3FE school with leadership capacity challenges. Galaxy Trust have been providing support for several months and the school now wants to join the trust. RSC decision: Approve Conflicts: None Further actions required: None Project: Fairview Community Primary School, Medway, to join The Westbrook Trust HTB discussion: The school was asked to do a formal consultation before the HTB decision after parents raised concerns. A majority of responses to the consultation were not in favour of the school to join Westbrook Trust. The governing body, having taken these concerns into consideration, but still feel The Westbrook Trust is the best option for the school. It was noted that the LA had formally raised concerns surrounding the governing body's decision making, specifically around transparency and community engagement. Members raised concerns that the governing body was at odds with the school community. The RSC was minded to ask the LA to work with the school to address the concerns.
