Thank you for your email of 14 December 2020 requesting the following information:

I should be grateful if you could provide me with the unit service history and the maintenance history for the Penman trailer ERM XM76AA from the JAMES system as there is no documentation in regards to this asset in the Merlin archive.

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that some information in scope of your request is held. The information you have requested can be found at annex A.
