

	<p><b>Side Roads Order</b></p> <p>Article 1(2) of Specimen form B (Local Authority Circular 1/97) has been omitted from the published Side Roads Order.</p> <p>Article 1(2) of Specimen reads;  ‘Where a new highway is to be constructed (wholly or partly) along the same route as a new access that new highway shall be created subject to the private rights over that new access.’</p> <p>The Council considers that the inclusion of Article 1(2) would be appropriate and respectfully invites the Inspector to make a modification to the Side Roads Order to include Article 1(2); in addition to the amendment (set out at 10.5.3 of the Statement of Case) to include the following notes on the Side Roads Order plans;</p> <p>Site Plan 5: ‘Bridleway A coexistent with a private vehicular right of access for Wickham Hall’</p> <p>Site Plan 6: ‘Bridleway A and B coexistent with a private vehicular right of access for Wickham Hall’.</p>	
	<p>Article 2 of the Order states ‘..... ,and letters E and F in Schedule and Site Plan numbered 2 with the words ‘temporary footpath’ placed in brackets above and beneath, ...’. It is proposed to modify this to read ‘..., and letters E and F in Schedule and Site Plan numbered 2 with the words ‘temporary footpath’ placed in brackets beneath, ...’ should the Order be confirmed.</p> <p>HCC proposes to delete ‘above and’.</p>	
	<p>It is proposed to modify the name of the Plan Folio (by inserting the brackets) to ‘The Hertfordshire County Council (A120 (Little Hadham) Bypass Classified Road) (Side Roads) Order 2017.</p>	
	<p>It is proposed to replace Site Plan 3 with that attached amendment.</p> <p>And amend the wording in Schedule 3 as follows;</p> <p><b><u>Highways to be improved:</u></b></p> <p><b>Albury Road C15 for 145m southwards and 120m northwards from its junction with Bridleway (Little Hadham) BR037 and for 360m southwards from its junction with Footpath (Albury) FP011.</b></p>	
	<p>The published Site Plan 3 incorrectly referenced ‘(Little Hadham) FP011’ and should read ‘(Albury) FP011’.</p> <p>The revised Site Plan 3 includes this amendment.</p>	
	<p>It is proposed to amend Schedule 4 to read;</p> <p>‘Site Plan 4: River Ash Maintenance Access’</p>	

	<p>The following modifications are proposed to Schedule 7:</p> <p>under 'Highways to be improved': 'Hadham Road (the existing A120) 265m (insert) south westwards from its junction with Bridleway (Bishop's Stortford) BR018.' and</p> <p>under 'Private means of access to be stopped up': 1s – 'Vehicular access to a field on the south side of Hadham Road (the existing A120) 200m to the west of Bridleway (Bishop's Stortford) (amend) BR018.'  2s – 'Vehicular access between fields from the 'Plantings Cottages' near to Hadham Road (the existing A120) for a distance of 300m north (insert) westwards.'</p>	

	<b><u>Compulsory Purchase Order</u></b>	
	It is proposed to modify the title of column 3 of Table 1 and column 5 and 6 of Table 2 of the Order to remove the 'the' included within the name of the Act so that it reads 'Qualifying persons under section 12(2)(a) of the Acquisition of Land Act 1981 – name and address' should the Order be confirmed.	
	It is proposed to modify columns 5 and 6 of Table 2 to read 'Other qualifying persons under section 12(2A)(a) of the Acquisition of Land Act 1981' and 'Other qualifying persons under section 12(2A)(b) of the Acquisition of Land Act 1981 – not otherwise shown in Tables 1 & 2' respectively should the Order be confirmed.	
	The descriptions of plots 3/2 and 3/3 read '...situated to the west of Albury Road and to the north of Little Hadham Village ...'. It is proposed to modify these descriptions to read '...situated to the west of Albury Road and to the north east of Little Hadham Village ...' should the Order be confirmed.	
	Similarly, the descriptions of plots 3/4, 4/2 and 5/3 state 'north of Little Hadham Village' and it is proposed to modify the descriptions of these plots to 'north east of Little Hadham Village' should the Order be confirmed.	
	It is proposed to modify the descriptions of plots 4/7 and 4/9 to read '... situated to the north west of Church End Farm buildings ...' should the Order be confirmed.	
	It is proposed to modify the description of plot 8/5 to read '... situated to the north west of the Hadham Park building' should the Order be confirmed.
