

NOTICE OF ORDER

Town and Country Planning Act 1990

Copeland Borough Council (Footpath No 406001 and 406006 Parish of
Egremont) Public Path Stopping Up and Diversion Order (No 1) 2020

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is 6 January 2021

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert the whole width of that section of footpath no. 406001 at Whangs Beck in the parish of Egremont from GR 300042 510851 53 metres northwards and northwestwards to GR 300033 510903; to run from GR 300027 510892 14 metres north-northwestwards to GR 300033 510903. The width of the new path will be two metres; and stop up the whole width of that section of public footpath no. 406006 at Whangs Beck in the parish of Egremont from GR 300042 510851 eastwards for about 226 metres to GR 300260 510798.

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 20 January 2021]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 3 March 2021]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents -

these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 14 April 2021]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

This Order is made by Copeland Borough Council ("the authority") under Section 257 of the Town and Country Planning Act 1990 ("the 1990 Act") because it is satisfied that it is necessary to stop up and divert the footpaths to which this order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the 1990 Act namely: 4/19/2044/0F1 Creation of three flood storage areas, landscaping and associated works land at How Bank Farm, Whangs Beck, Falcon Club, West Lakes Academy and West of Croadalla Avenue, Egremont

BY THIS ORDER:

1. The public footpaths over the land situate in the Parish of Egremont shown by continuous bold lines on the map attached to this Order and described in Part 1 of the Schedule to this order shall be stopped up as provided below.
2. There shall be created to the reasonable satisfaction of the authority an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order.
3. Despite this Order all statutory undertakers shall continue to have any existing rights of access to and egress from any apparatus, equipment and plant accessible only from the rights of way referred to in Part 1 of the Schedule to this Order
4. The Copeland Borough Council (Footpath Nos 406001 and 406006 Parish of Egremont) Public Path Stopping Up and Diversion Order 2020 is hereby revoked
5. The stopping up and diversion of the footpath shall have effect on the confirmation of the Order and shall be cited as the Copeland Borough Council (Footpath Nos 406001 and 406006 Parish of Egremont) Public Path Stopping Up and Diversion Order (No 1) 2020.

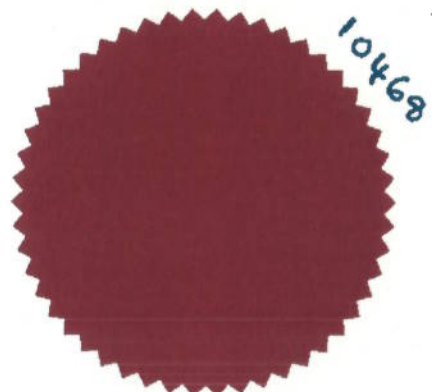

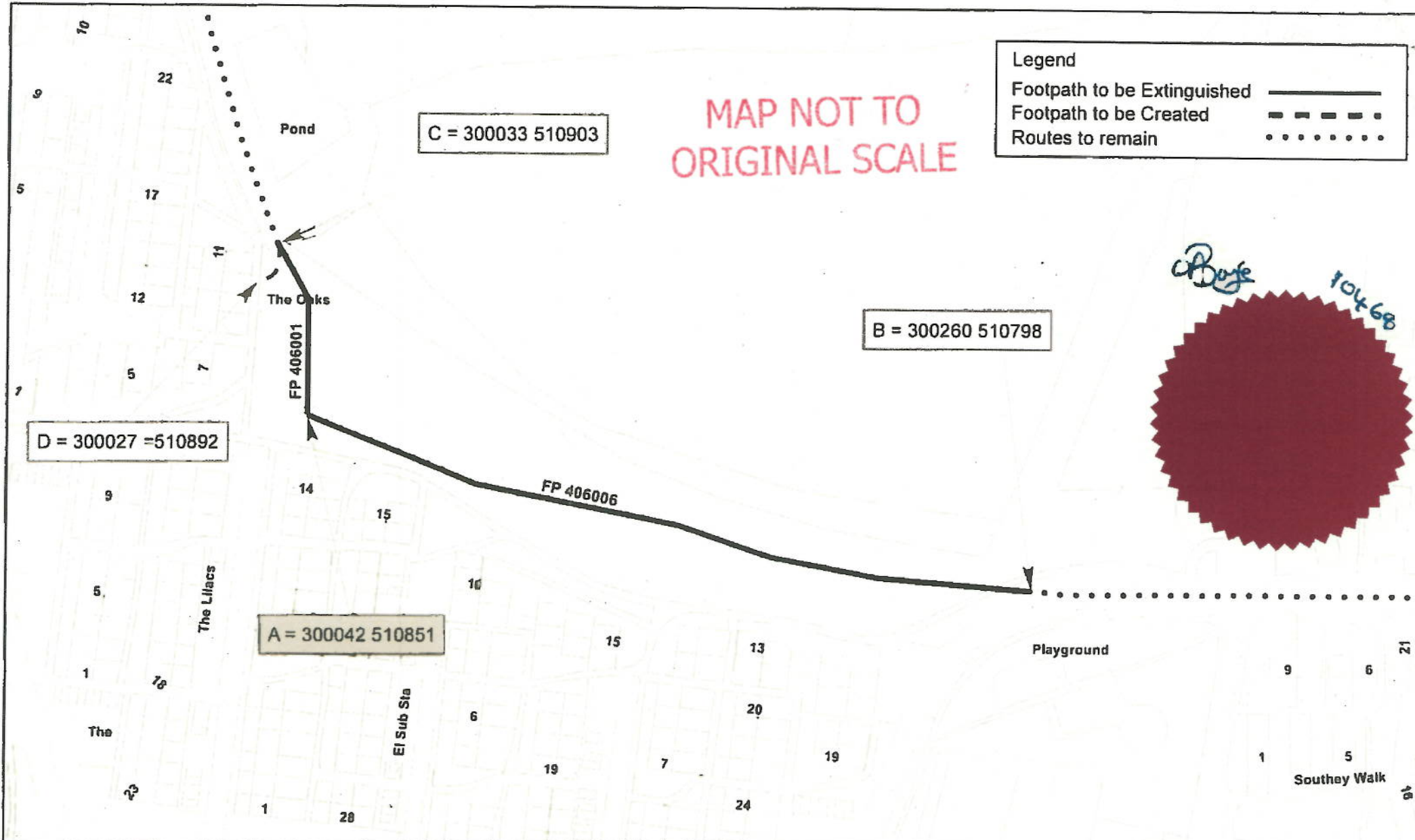
