**REQUEST FOR INFORMATION – INFORMATION RELATING TO THE DEATH OF R/CON WILLIAM CLIFFORD EVANS ON 5 JANUARY 1976**

I can confirm that your request has been considered under the provisions of the Freedom of Information Act 2000 (FOI (A)), and the process is now complete.

You asked the following:

***“FOI request for Army Records (case of Reserve Constable William James Clifford Evans, murdered by the IRA on 5 January 1976)***

***[REDACTED] Reserve Constable Willaim James Evans, was murdered by the IRA when he was shot at on the Blackpark Road, Creagh, on 5 January 1976.***

***Under the Freedom of Information Act 200 I would like to request the Army records between 4<sup>th</sup> and 6<sup>th</sup> January 1976 in relation to this incident.”***

I can confirm that the MOD holds some information relating to the death of R/Con William James Clifford Evans. This information has been located in a range of documents and relevant extracts of these have been provided at Annex A.

Some of the information falls within the scope of Section 38 (Health and Safety) of the FOI(A), as its release could endanger the physical or mental health of any individual or endanger the safety of any individual.

Section 38 is a qualified exemption and we have conducted a public interest test to determine whether the information should be released or withheld. The factors for this public interest have determined that whilst disclosure would demonstrate openness and transparency this is outweighed by the detrimental effect disclosure could have on those mentioned in the documents, or their family members and friends. I have concluded that whilst disclosure may be of historical interest, the health and safety of individuals must be taken into account. Some information has therefore been redacted under Section 38 of the FOI(A).

In addition, some of the information contained within the disclosure constitutes personal information, such as names and addresses. Under FOI(A) this information is exempt under Section 40 (2) by reason of the first condition under Section 40 (3) (a) (i), as disclosure would contravene data protection principles under the Data Protection Act 2018 (DPA 2018). This is an absolute exemption and does not require a public interest test to be conducted in order for this information to be exempt from disclosure. Therefore, all personal information has been redacted.

I appreciate that this incident took place 44 years ago and the passage of time can be a factor in diminishing the applicability of exemptions to information. However, in this instance the overall balance is in favour of partial exemption.

5 January 1976

4. Rural Areas

b. 8 Inf Bde

(1) A RUC Constable was shot dead and 2 Constables wounded when their patrol car was ambushed near Toome. The wounded men are not seriously ill.

8 INFANTRY BRIGADE

4. 1 WFR (POLICE DIVISIONS O AND P) ↓ SHOTS AT SF

a. The SF were involved in the only shooting incident reported when at 2240 hours a routine RUC mobile patrol was fired at when the vehicle stopped at the junction at GR 968916, approximately 3 km north west of TOOME. The following was shot dead:

Reserve Constable Clifford EVANS, from BELLAGHY ← 1 RUC(k)

The following were admitted to the MID ULSTER Hospital with minor injuries 1 RUC Constable shot dead  
and were later released: 2 Constables injured Nr TOOME

The shots first came from the yard of the ELK Bar nearby and then from a van, thought to be a VW van, as it drove off past the police car. In the follow up 10 x 7.62 empty cases were found by the wall round the ELK Bar yard and a further 8 Armalite and 7.62 live rounds and empty cases scattered along the road. The RUC MAGHERAFELT are investigating.
