#### PROVISION OF REQUESTED INFORMATION

Thank you for your request for information on gamebirds which we received on 29 January 2020. Your request has been handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

"we would like to have the Poultry Register data for each year individually from 2009 until 2019 that reports the numbers of each SPECIES of gamebird (categories = "pheasant", "partridge", "mallard") whose ANIMAL PRODUCTION USEAGE CODE is "shooting" or "other", separated by their LU PURPOSE ("Rearing for shooting", "Breeding for shooting", "Releasing for shooting"). These data should be separated by geographical location at the finest possible scale, while retaining anonymity for individual registees. Ideally, data would be at a coordinated 10x10km UK grid square or a 4 digit postcode, but if you were able to provide it at a finer scale (e.g. 5x5km grid square), that would be greatly appreciated. This amalgamated data should also include the number of registees in that location."

Please refer to Appendix 1 for the figures you have requested. The information provided is current at the time of this response.

Each region row, shown on Appendix 1 does not represent an individual premise. The number of premises may be different to the number of birds because a premise can have several flocks.

The information provided is the average population of poultry passed to the Animal and Plant Health Agency (APHA) when a premise is initially registered. The 'usual stock numbers' are the number of birds provided by the poultry keeper upon registration.

The Poultry Register has not been in existence since 2014 when APHA was formed, and APHA do not publish reports. However historical reports from the former AHVLA are still

Some of this information is being withheld under Section 40(2) of the Freedom of Information Act (2000).

#### Section 40

APHA can confirm the requested information is held, but maintains its decision to withhold it under section 40(2) as the information constitutes personal data relating to a third party.

Personal data relates to a living person and APHA consider the addresses would make individuals identifiable by being linked to them. We can confirm, in many of the post code regions we have provided to you, there are less than five premises. This makes identifying individuals more likely. Section 40(2), read in conjunction with 40(3)(a)(i), of the FOIA provides that personal data relating to third parties is exempt information if disclosure would breach the Data Protection Act 2018 (DPA).

APHA consider that disclosure of this information is likely to breach the first data protection principle in Schedule 1 of the DPA, which relates to the fair and lawful processing of personal data, in two ways. First, disclosure would not constitute 'fair' processing of the personal data, second, disclosure would not satisfy any of the conditions for data processing set out in Schedule 2 to the DPA. Therefore, we have concluded that this information is exempt from disclosure under section 40 of the FOIA.

We note from your email that you are carrying out this research on behalf of Natural England. You may wish to considered applying for a Data Sharing Agreement, which might allow APHA to release more detailed data for your review. APHA will consider Data Sharing Agreements for research purposes. Requests undergo a rigorous approval process, the purpose is considered and recipients are assessed as to who they are, and their organisation's compliance with Data Protection law. In addition, APHA expects to receive outputs to our benefit from the sharing so it is in our interest as well as the wider public.
