## **PROVISION OF REQUESTED INFORMATION**

Thank you for your request for information regarding live testing of animal traps which we received on 5 May 2020. Your request has been handled under the Freedom of Information Act 2000 (FOI).

The information you requested and our response is detailed below:

"the testing of the Goodnature A24 device which gained approval under The Spring Traps Approval for use in the UK.

Kindly provide the following information:-

1. The number by species (rats, stoats and hedgehogs) of the tests <u>conducted by APHA</u> with the device on live animals.

APHA can confirm that the following tests have been conducted – Rats – 12, Stoats – 0 and Hedgehogs – 0 (hedgehogs are not a target species and it is not legal to use the A24 for this species)

2. The efficacy of the device in the case of each species.

APHA can confirm that 83% of trials met the required standards for rats.

3. Was the A24 tested when fitted with an excluder to prevent harm to protected species."

APHA can confirm that all trap testing is carried out to manufacturers instructions in a controlled environment where only the target species is present.

Specific details regarding the A24 trap have been have been exempted from release under Section 43 of the FOIA, details of which can be found below. Please note that

under Section 43 we are unable to disclose information that would be likely to prejudice the commercial interests of any person, and as such this exemption has been applied.

## Section 43

Section 43(2) of the FOIA exempts information if its disclosure under the Act would or would be likely to prejudice the commercial interests of any person. The exemption in Section 43 is subject to a Public Interest Test to ensure it is being appropriately applied.

## Public Interest Test

APHA recognise that there is a general presumption in favour of openness and transparency concerning our work, and providing the general public with the right to request access to information held by public authorities.

APHA also recognise that this would increase transparency and aid well-informed debates concerning our work and how we select traps to test.

However, APHA's relationship with stakeholders is based on trust. Releasing this information could prejudice the commercial interests of any such establishments. This could lead to financial losses.

Furthermore, this would result in breach of confidentiality between APHA and its customers and could potentially lead to an adverse working relationship and interfere with the relevant Public Authority carrying out its statutory duties.

APHA have concluded that, in all the circumstances of the case, the information should be withheld under Section 43(3) of the Act at this time.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.

An Annex is attached which explains the copyright that applies to the information being released to you and contact details should you be unhappy with the service you have received.
