RSC update

• The RSC gave an update on the current position across the region with relation to the Covid crisis and asked HTB for any reflections.

Discussion of projects, including decisions made by RSC with advice from HTB

All decisions are made in reference to relevant legislation and the published criteria.

Academy Orders and MAT Approvals

Project: Chartham Primary School and St Stephen's Infant School, Kent, to convert and form MAT

HTB discussion:

Proposed governance structure and terminology for roles (ie.CEO, CFO) due to the size of the primary schools. Need to manage expectations around future growth given the opportunities in the area.

Potential financial issues given under PAN and can the capital issues be resolved before the schools convert. 8% GAG is quite low.

St Stephens Juniors should be part of this discussion. Perhaps look to governors to see whether there are any options to bring the infant and junior school together.

Project: Potential in Everyone Academy Trust and The Village Academy, Kent, to merge

HTB discussion:

This is a positive merger. General point that we are likely to see more trusts merging and should therefore consider whether a one year to 18 months period of consolidation might be needed after mergers to allow time for new arrangements to bed in. Important to have these conversations between trusts before mergers come to the RSC for approval.

Pupil numbers are still not very high so the trust need to be cautious about growth.

New trust leadership looking at cautious and local growth. Some financial issues previously but LA have agreed to write these off. LA and ESFA are positive about the progress.

HTB discussion:

Financial issues at Weydon MAT but ESFA confident that there is plan in place to help them manage their debt. However, awaiting visit and report from SRMA. Worrying that financial position is deteriorating. Reserves reducing and projected to reduce further.

Project: Learning and Inspiration for Tomorrow Partnership, Surrey, to join The Howard Partnership Trust

There was a question on governance.

Project: Windlesham Village Infant School, Surrey, PAN reduction

HTB discussion:

Pupil numbers have declined with expected surplus of spaces in the area. Fear that school will become unviable if action isn't taken quickly.

Project: Roseland Infants School, East Sussex, to join The Cavendish School (Eastbourne)

HTB discussion:

Change in governance proposed based on an approval date of April 2021. More urgency needed here.

There was a question as to whether CEO can be a trustee and confirmation that this is allowed.

Trust to reduce the number of trustees and notify the RSC Office of their revised governance structure by the end of January 2021, with the structure in place before the schools convert on the 1st April.

Project: University of Portsmouth Academy Trust application, to become a MAT

HTB discussion:

Question on who was driving the creation of this MAT. Would want to see a named individual to take forward vision and direction and to look at the gaps particularly around governance.

There is concern around school improvement experience and the details of how this would be operationalised.

Potential trust needs a strong school improvement partner to support the trusts' development.

Project: Corpus Christi Catholic Primary School, Portsmouth to join Edith Stein Catholic Academy Trust

HTB discussion:

The trust is still revising the number of trustees based on condition from previous HTB meeting. On top of educational expertise, the trust also has a condition that trustees must be Catholic, which is the reason for delay.

Concern that it will be a secondary MAT sponsoring a primary school. Will need to monitor the school and trust given that Ofsted will not be inspecting the school for three years post-conversion.

Wider issue around Church schools having to join a limited number of trusts.

Trust to reduce the number of trustees as soon as possible. RSC to discuss with Catholic Diocese possibility of getting trustees in post earlier than September 2021.

Project: Application from HISP Multi Academy Trust, to become a Sponsor
