





- 2/ Why has this information been deleted in Homes\_England\_Land\_Hub\_List\_Of\_Sites\_Q3\_2020.csv, if there are different reasons per parcel then please state each reason.
- 3/ Why have previous csv data files been completely deleted/removed rather than remaining transparent and still being accessible?
- 4/ What is the protocol when deleting past published documents and information?
- 5/ Should past published documents and information not remain achieved for transparency?

I'd like the contents of this email fully published for transparency in response, redact my name and email address, but include all information and the table of properties removed from the land hub.

#### **Response**

I am able to confirm that Homes England does not hold any recorded information that falls within your request. This is because the FOIA does not oblige Homes England to respond to 'why' questions, but to provide recorded information.

In order to conclude that the information is not held, we have searched with our Land Hub team who would have the requested information if held.

The FOIA does not oblige a public authority to create information to answer a request if the requested information is not held. The duty under section 1(1) is only to provide the recorded information held.

# **Advice and Assistance**

We have a duty to provide advice and assistance in accordance with Section 16 of the FOIA. To comply with this duty we are able to provide the following advice regarding the land hub.

The Land Hub is our marketing tool for all sites that are either currently on the market or those that are due to be placed on the market within 6 months.

The data is amended/updated on the platform on a quarterly basis to reflect the current position on those sites.

Sites are displayed that meet a set reporting criteria. The criteria for which sites are shown does not change between updates except for the timeframe. No data is actively deleted or removed from the land hub, the previous CVS file is simply replaced with the quarterly update. If data isn't displayed on the land hub it is because it doesn't or no longer meets the criteria for inclusion in the report.
