Draft Code of Construction Practice	Feb 2019	Addition of section 5.17 and annex 4.	Additional Provision 2 modified the High Speed Rail (West Midlands - Crewe) Bill so that it disapplies sections 8o(2)(b), 81 and 82 of the Building Act 1984. These sections of the Building Act apply certain controls to demolition works. The additions to the draft Code of Construction Practice put in obligations that will ensure the effects of demolitions on people and the environment are correctly managed. These include the preparation of Demolition Plans. Annex 4 to the draft Code of Construction Practice provides a template for these Demolition Plans.	2
